Local Economy, Finances, and Gwinnett's Excellent Credit History

- Estimated 2012 population was 837,873 (Moody's Analytics Forecast
- Gwinnett's employment totaled 406,711 in November 2012 (Georgia Department of Labor, preliminary, not seasonally adjusted)
- Gwinnett's unemployment rate was 7.1 percent in November 2012, compared to 8.3 percent statewide, marking 43 straight months that Gwinnett has had the lowest rate among the five core metro Atlanta counties (Georgia Department of Labor, preliminary, not seasonally adjusted)
- Gwinnett has maintained AAA bond ratings with Fitch Ratings, Moody's Investors Services, and Standard and Poor's since 1997
- Only 39 of the nation's more than 3,000 counties can boast triple AAA ratings
- Saved about \$2.2 million by refinancing 2003 General Obligation Bonds
- First large county and third overall to receive tax digest approval from the Georgia Department of Revenue

Special Purpose Local Option Sales Tax (SPLOST)

- 2009 SPLOST program forecast to raise \$688 million (April 2009 to March 2014)
- County proceeds designated for transportation, public safety, park, library, and courthouse expansion projects
- Gwinnett's cities are sharing an estimated \$100 million from 2009 SPLOST program
- 2001 SPLOST program closed in 2012 after raising \$496+ million for libraries, parks and recreation, public safety, transportation, and city projects

Planning, Economic Development, and Revitalization

- Adopted 2030 Water and Wastewater Master Plan
- Developed Housing Task Force leading to the HomeSafe Georgia kickoff
- Implemented online plans submittal training including an online instructional video
- Encouraged redevelopment by amending development regulations
- Achieved substantial progress toward completion of Unified Development Ordinance

Community Services

- Cooperative Extension Service presented 1,291 programs on youth, family, and environmental issues
- Gwinnett Environmental and Heritage Center relocated two historic structures to its campus: Chesser-Williams House and Lee Barn
- Work got underway on an expansion of the federally funded Senior Services Center that includes a new kitchen for the home-delivered meals program
- Friends of Gwinnett County Senior Services raised more than \$150,000 for programs and services
- Five Forks Branch Library renovation funded by SPLOST was completed
- SPLOST-funded major park renovations and new parks opened: Rhodes Jordan Park, Vines Park, Bryson Park, and Yellow River Post Office historic site
- Purchased Fort Daniel historic site with SPLOST funds
- Parks and Recreation celebrated $25^{\mbox{\tiny th}}$ anniversary as a countywide system
- Elections conducted eight elections and processed about 1.2 million voter transactions; there are 467,210 registered voters in Gwinnett County
- Community Services worked with almost 650 community partners to provide services
- Volunteers donated more than 940,000 hours of service

2013 Adopted Budget

January 2013

- \$1.463 billion balanced budget: Operating Budget totals \$1.058 billion and Capital Budget totals \$404.7 million
- Shaped by loss of revenues from continued decline in tax digest, service-delivery agreements with cities, new state and federal mandates, and formation of City of Peachtree Corners
- Budget highlights: preserves core services; establishes new service district funds for police, fire/ emergency medical, and development/code enforcement; no pay raises; adjusts employee benefits to absorb increase in required coverage; continues 90-day vacancies for positions; complies with all new state and federal mandates
- Anticipates an additional 2 percent drop in the value of the property tax digest in 2013
- Six residents and business people assisted Chairman Nash and County staff in prioritizing needs and allocating resources

Transportation

- Completed Sugarloaf Parkway Extension to State Route 316
- Began construction on Pleasant Hill Road at I-85 Diverging Diamond Interchange (DDI)
- Completed engineering and accepted bids on Jimmy Carter Boulevard at I-85 DDI
- Began Traffic Control Center (TCC) enhancements, including upgrades to GC Smart Commute
- Retimed 10 corridors with 108 signals and conducted 12 signal installations, eight signal rebuilds, and numerous signal modifications

- Began installation of new safety and security measures through Computer Aided Dispatch/Automated Vehicle Location for Gwinnett Transit
 Opened 25+ projects to traffic with 20+ projects in desire phase and meurfored 120 miles of used in the safety of the saf
- Opened 25+ projects to traffic, with 20+ projects in design phase, and resurfaced 130 miles of roadway
- Completed engineering and land acquisition for widening State Route 20 in the Buford/Sugar Hill area including the new bridge over the Chattahoochee River

General Government

- State-administered *HomeSafe Georgia* mortgage assistance program kicked off in Gwinnett County
- Implemented solid waste and recycling changes in 2013, providing a 15 percent discount to qualified seniors and exempting vacant properties with valid permits from residential fees
- Reached service delivery agreement with 15 cities
- Launched Volunteer Gwinnett program to help the County provide valuable services; 991,122 volunteer hours exceeded the 2012 goal by nearly 40 percent
- Office of the Tax Commissioner achieved the highest property tax collection rate since 2004: 96.7 percent
