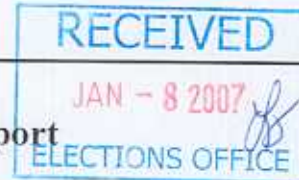

During the reporting period, the committee entered into a loan agreement with Brand Banking Company under which we could borrow up to One Hundred Thousand Dollars (\$100,000.00) on an unsecured basis. The committee did not draw down any money under this loan agreement and canceled the loan in December of 2006.

This report also includes deposits made on January 5, 2006 equally \$11,000.00.
