- ☐ Inventory records are available for review.

SIGNAGE

- ☐ No Smoking signs are posted and visible.
- ☐ Signs are posted to indicate that a person *Must be 18 Years of Age to Purchase Fireworks.*

FIRE EXTINGSUISHERS


☐ A properly serviced 10 lb. multi-purpose type ABC dry chemical fire extinguisher (4A:40B:C rated) AND a 2½ gallon pressurized water extinguisher (2A rated) is located on site.

SITE LOCATION

- ☐ Fireworks are not located at check-out isles.
- ☐ Fireworks are stored in the same location as listed on the permit application.
- ☐ Fireworks displays are not located within 5' of a store entrance.

OPERATIONS

- ☐ The fireworks display is visually supervised while the store is open.
- ☐ Only packaged fireworks are displayed for sale.
- ☐ Sales displays do not exceed 6' in height and combustible\$ are stored above the display.
- ☐ Exits are marked and easily accessible.

Preparing Your Retail Fireworks Display

This brochure is provided as a tool to ensure retail fireworks sales tents and stands operate in accordance with National Fire Protection Association (NFPA) Code

PREPARING FOR OUTSIDE TENT AND STAND SALES

PAPERWORK

☐ A site plan is available indicating the correct address and showing the locatin of the tent/stand on the site.

☐ The tent/stand size is the same as what is listed on the permit.

☐ Paperwork is availale indicating the hours of operation and indicating how the fireworks will be secured after hours.

☐ A flame spread certificate is available for the tent or canopy.

SIGNAGE

☐ EXIT signs are posted at all exits.


☐ Signs are posted on the exterior of <u>each</u> side of the tent or stand to indicate *No Fireworks Discharge within 300 feet.*

□ *No Smoking* signs are visibly posted at the entrance to the tent or stand.

☐ Signs are posted at the cash register to indicate that a person *Must be 18 Years of Age to Purchase Fireworks*.

FIRE EXTINGSUISHERS

☐ A properly serviced 10 lb. multi-purpose type ABC dry chemical fire extinguisher (4A:40B:C rated) AND a 2½ gallon pressurized water extinguisher (2A rated) is located on site.

SITE LOCATION

☐ If the tent/stand is set-up in a grassy field, the area was cleared of weeds and debris before set-up.

☐ The tent/stand placement matches the submitted site diagram.

☐ The tent/stand is located

- 10' away from vehicle parking.
- 20' away from buildings or storage containers.
- 30' away from combustible materials.
- 50' away from vehicle fuel dispersing areas.

OPERATIONS

☐ A minimum of two exits are provided and both are clearly marked.

☐ Both exits are easily accessible (minimum 44" clearance opening in tents and 32" clear width in stands).

☐ The fuses of all fireworks in the sales display are covered.

☐ Sales displays do not exceed 6' in height and no combustible materials are stored above the fireworks display.

☐ Security is provided for the tent/stand or portable container/building after business hours.

☐ Generators are located at least 20' away from the tent or stand.

☐ Generator fuel is stored in an appropriate UL listed fuel container.
