**GCPR Scholarship Information:** Scholarships are limited to two awards for GCPR administered classes/programs per Family/Members of the same address per year. Incomplete or misleading applications will be rejected. Misleading application information or expulsion from a program will result in placement on scholarship probation for a period of one year from the date of application. Priority will be given to first time applicants. **All scholarships are awarded based on demonstrated need, available funding and meeting deadline requirements.** I understand that such participation may include being photographed for publicity purposes.

**Registration Information:** Recipients will be notified no later than two weeks after the deadline for the registration quarter for which they are applying. If approved, recipients will be issued a confirmation letter/email to use when proceeding with mail or walk in registration, in compliance with GCPR's standard registration procedures. The scholarship program is separate from the registration process and application or receipt of a scholarship does not guarantee space into a class, program or camp. Any additional fees must be paid at the time of registration by the participant.

**Applications that do not meet the minimum criteria below, will not be considered**

**Participant Scholarship Criteria:** In need of financial assistance as outlined below; age 17 and under for youth recreation or over 50 for senior recreation; Gwinnett County resident; complete application (including supplemental information); meet deadline requirements above; meet all other GCPR eligibility, guidelines and class requirements; has not been placed on scholarship probation.
