Gwinnett County Parks & Recreation (GCPR) Cancellation Policy 1) Participants enrolled in any class cancelled by GCPR will receive a full refund. 2) Customers who make a written cancellation request 7 or more days prior to start of class will receive a full refund. 3) Customers who make a written cancellation request less than 7 days prior to start of class will be charged a \$25 processing fee or an amount equal to half their total class fee (whichever is less). The remainder of the class fee will be refunded. Instead of a refund, participants may elect to receive a full credit towards another comparable class. The credit must be used within one year of issuance. 4) No refunds or credits will be issued after starting date of class. Please allow up to four weeks for all refunds. *Optional fees may apply to some programs.
