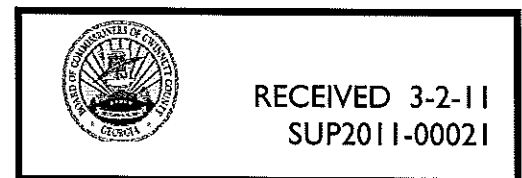


LETTER OF INTENT
