On motion of **Beaudreau** which carried **5-0**, the Gwinnett County Board of Commissioners hereby adopts the following Resolution:

A RESOLUTION AMENDING THE GWINNETT COUNTY ANIMAL TASK FORCE RESOLUTION ADOPTED AUGUST 23, 2011

WHEREAS, Gwinnett County Board of Commissioners adopted a Resolution creating the Gwinnett County Animal Task Force on August 23, 2011; and

WHEREAS, the Resolution creating the Gwinnett County Animal Task Force provided for seventeen (17) appointments to the Task Force; and

WHEREAS, three veterinarians have been appointed to the Task Force to fill the Commissioner citizen appointments;

WHEREAS, the Board of Commissioners believes that veterinarians are adequately represented on the Task Force and desires to re-designate the veterinarian appointment as a citizen representative appointment; and

WHEREAS, the Board of Commissioners desires to provide the Animal Task Force with sufficient additional time to complete the objectives as outlined in the Resolution creating the Animal Task Force in a thorough and thoughtful manner;

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners does hereby amend the Resolution creating the Gwinnett County Animal Task Force by re-designating the veterinarian position as a citizen position.

BE IT FURTHER RESOLVED that the Resolution creating the Animal Task Force be further amended to extend the deadline for the Animal Task Force to submit its final recommendations and findings to the County Administrator and the Board of Commissioners until March 31, 2012.


