ADDENDUM #2 BL038-24, West Gwinnett Aquatic Center Pool Renovations

REVISIONS:

R1. I. SCOPE OF WORK, #1 shall be revised to the following: Work on the indoor pools should be completed no later than August 23, 2024. Work on the outdoor pool should start on September 3, 2024 after the Labor Day holiday. All work shall be coordinated with the County Representative.

QUESTIONS & ANSWERS:

- Q1. Is Gwinnett County providing all of the replacement tile?
- A1. Yes, the County will provide replacement tiles for all pools. All black tiles shall be left in place and all blue tiles shall be removed and replaced with black tiles.
- Q2. Are the expansion joints being removed and replaced?
- A2. Yes.
- Q3. How many layers of plaster are in each pool?
- A3. The indoor pools are original, and the outdoor pool has one additional layer.
- Q4. Does the plaster on the outdoor pool need to be removed?
- A4. Plaster removal for the outdoor pool shall be included as an Add Alternate to the project. Please see Attachment 1 for the REVISED BID SCHEDULE.
- Q5. Is the plaster to be replaced with white plaster?
- A5. Yes, plaster shall be conventional white marble finish.
- Q6. Will the contractor be responsible for installing depth markers?
- A6. Yes, the contractor will be responsible for installing new depth markers. Depth markers shall be provided by the County.
- Q7. Are the 1"x1"s on the play structure being removed and replaced?
- A7. Only chipped or damaged tiles shall be replaced.
- Q8. Do we need to re-grout the tile in the outdoor pool?
- A8. Yes, the awarded contractor shall be responsible for re-grouting and cleaning the tile in the outdoor pool.

Q9. Please specify the start date and/or time allotted to complete the indoor pools.

A9. The contractor shall commence work within 10 days of the issuance of the Notice to Proceed. Indoor pools should be completed no later than August 23, 2024. All installation shall be coordinated with the Department of Community Services.

Q10. Are the main drains being replaced?

A10. Yes, the main drain covers and hydrostats shall all be replaced.

This addendum should be acknowledged in the space provided on page 13 of the bid documents and returned with your bid. Failure to do so may result in your bid being deemed non-responsive.
