## ADDENDUM #1 BL041-24 Purchase and Installation of Washer and Dryers

#### **CLARIFICATIONS:**

- C1. The County is pushing back the opening to March 21, 2024 at 2:50 PM.
- C2. The County has existing equipment in place that includes the control panel pictured below. Equipment bid should include control panels that function similarly to what is currently in place to keep the training for equipment usage consistent.



#### **REVISIONS:**

R1. Please revise Section A, Item 6 to read; A warranty that carries a three (3) year minimum guarantee against defective materials and workmanship from the date of acceptance and includes 100% labor and materials coverage for at least thirty (30) days. In addition, a 10-year warranty for the frame, basket, shaft, bearing and seals.

#### **QUESTIONS AND ANSWERS:**

- 1. Will the Vendor be required to do any additional ductwork when installing the new machines? **No, there will be no additional ductwork required by the vendor.**
- 2. Can the Vendor bring their own forklift to the jobsite. Yes, the vendor may bring their own forklift.
- 3. What is the installation timeframe. The County would like the machines to arrive as quickly as possible after award. Due to funding, installation needs to be complete and invoice submitted for payment by December 19, 2024 in order to process payment before the end of the year. Delivery time may be used in determining award. Once awarded, the Vendor will work with the Sheriff's Office to schedule a delivery and installation.
- 4. Does the County prefer a hard or soft mount for the washer? The County is open to either option. Vendors are welcome to submit more than one option for consideration. If doing so, please submit each option as a separate bid package. Be sure to note option 1, option 2, etc. on the outside of the envelope. When evaluating bids, the County will evaluate hard mounts and soft mount options separately. The County will determine which option best meets their needs and award to the low responsive and responsible bidder for the selected mount style.
- 5. Does the County want a prison package? The Revised Bid Schedule includes line items for prison packages. The County reserves the right to reject these line items if it is in their best interest.

This addendum should be signed in the space provided below and returned with your bid. Failure to do so may result in your bid being deemed non-responsive.
