


Overview of Procedures

 - County disbursements – testing for proper approval
 - County budget amendments – testing for proper approval
 - County revenue and expenditures – testing for accuracy
 - City disbursements – testing for compliance with SPLOST Referendum
 - City disbursements – testing for proper approval
 - City revenue and expenditures – testing for accuracy



Overview of 2009 SPLOST Program




Dollars in Chart in Thousands

 - Total Overall Program Budget - \$814,548,433
 - Cumulative Program to Date Expenditures - \$788,489,801 (96.8% of total program)




Dollars in Chart in Thousands



□ City Disbursements

- 2020 - \$703,723
- Total Program Budget - \$135,647,461
- Cumulative Program to Date Expenditures - \$107,795,444 (79.5% of total program)



Summary of Testwork and Results – 2009 SPLOST

□ County Disbursements

- \$51,770,863 of disbursements vouched
- 48 items vouched
- No exceptions on any disbursement regarding compliance or approvals

□ County Budget Amendments

- 58 amendments tested (from original budget – not all in 2020)
- No exceptions regarding approvals

□ Revenue of \$3,828,143 agreed to general ledger and bank statements without exception.

□ Expenditures of \$63,097,500 agreed to general ledger and audited schedule without exception.



Summary of Testwork and Results – 2009 SPLOST

□ City Disbursements


- \$694,599 of disbursements vouched
- 20 items vouched
- No exceptions on any disbursement regarding compliance or approvals.

□ Revenue of \$4,750 agreed to general ledger and bank statements without exception.

□ Expenditures of \$703,723 agreed to general ledger and bank statements without exception.

Dollars in Chart in Thousands



Overview of 2014 SPLOST Program




Dollars in Chart in Thousands

- 2020 - \$2,285,209
- Total Program Budget - \$107,594,279
- Cumulative Program to Date Expenditures - \$91,777,327 (85.3% of total program)



Summary of Testwork and Results – 2014 SPLOST

□ County Disbursements

- \$27,182,175 of disbursements vouched
- 111 items vouched
- No exceptions on any disbursement regarding compliance or approvals

□ County Budget Amendments

- 53 amendments tested (from original budget – not all in 2020)
- No exceptions regarding approvals

□ Revenue of \$14,650,835 agreed to general ledger and bank statements without exception.

□ Expenditures of \$40,488,124 agreed to general ledger and audited schedule without exception.



Summary of Testwork and Results – 2014 SPLOST

□ City Disbursements

- \$2,247,763 of disbursements vouched
- 64 items vouched
- No exceptions on any disbursement regarding compliance or approvals.

□ Revenue of \$227,144 agreed to general ledger and bank statements without exception.

□ Expenditures of \$2,285,209 agreed to general ledger and bank statements without exception.



Overview of 2017 SPLOST Program




- County Disbursements (including payments to Cities)
 - 2020- \$150,320,572
 - Total Overall Program Budget - \$942,740,220
 - Cumulative Program to Date Expenditures - \$374,878,438 (39.8% of total program)

- 2020 - \$38,532,416
- Total Program Budget - \$201,780,000
- Cumulative Program to Date Expenditures - \$88,244,947 (43.7% of total program)

Summary of Testwork and Results – 2017 SPLOST

□ County Disbursements

- \$102,139,853 of disbursements vouched
- 172 items vouched
- No exceptions on any disbursement regarding compliance or approvals

□ County Budget Amendments

- 80 amendments tested (from original budget – not all in 2020)
- No exceptions regarding approvals

□ Revenue of \$191,685,857 agreed to general ledger and bank statements without exception.

□ Expenditures of \$150,320,572 agreed to general ledger and audited schedule without exception.



Summary of Testwork and Results – 2017 SPLOST

□ City Disbursements

- \$33,027,926 of disbursements vouched
- 195 items vouched
- No exceptions on any disbursement regarding compliance or approvals.

□ Revenue of \$42,659,420 agreed to general ledger and bank statements without exception.

□ Expenditures of \$38,532,416 agreed to general ledger and bank statements without exception.
