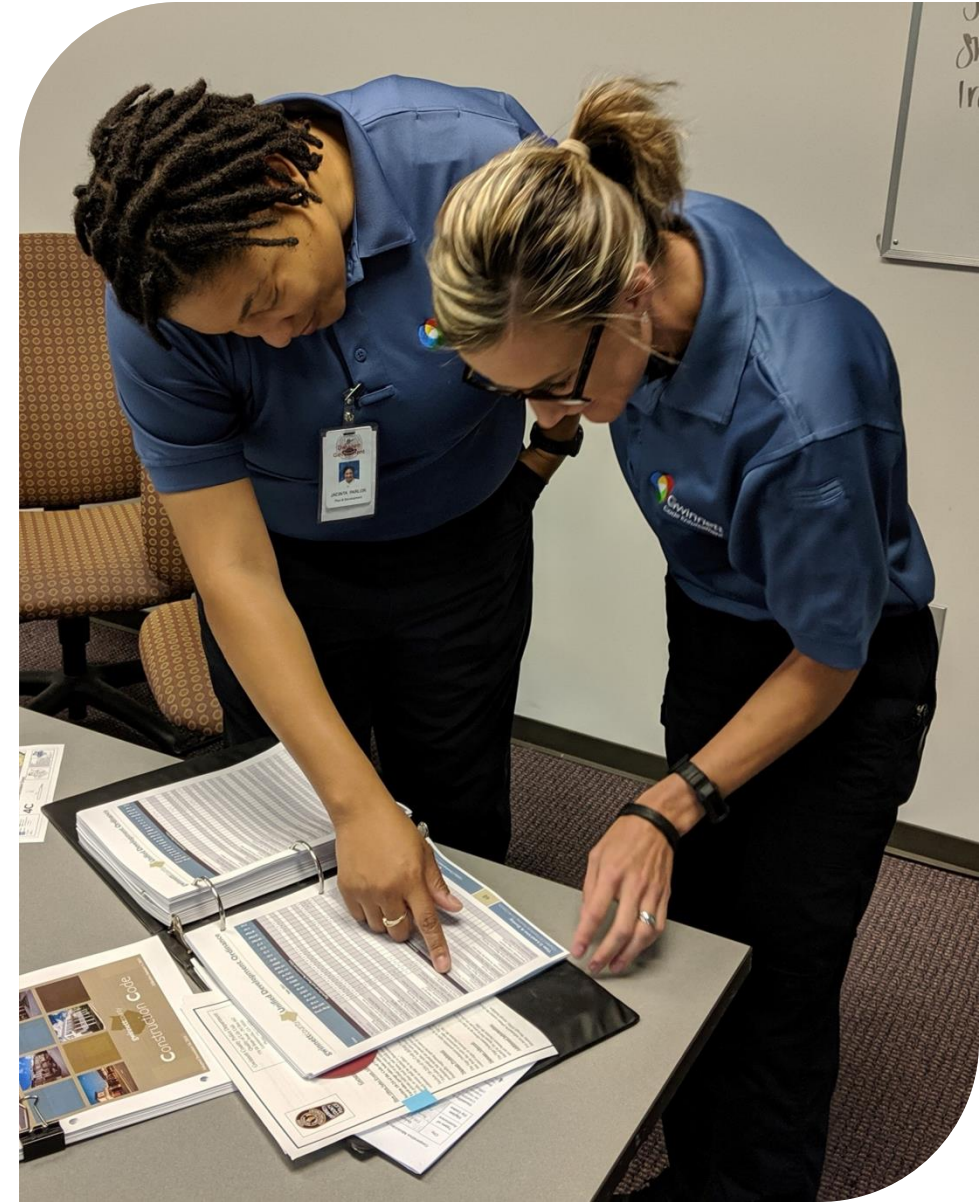


2019 Accomplishments
