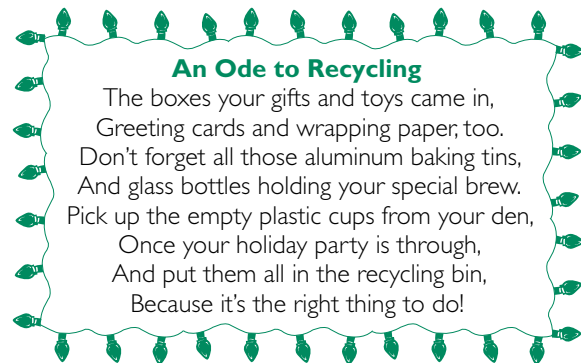

Examples include but are not limited to: wrapping paper (no plastic or foil varieties) and wrapping paper cores, gift bags, greeting cards, aluminum baking tins, beverage containers (some plastics, aluminum, and glass), and catalogs, plus most boxes and cardboard containers. Be sure to break down the cardboard. Please note that haulers will follow the normal trash and recycling schedule the week of Christmas and New Year's Day.

PROTECTING OUR RESOURCES

Illegal dump sites lead to polluted streams

Illegal dumping is a problem in Gwinnett County, which poses a threat to environmental and public health. Abandoned subdivision developments and buildings, empty lots, alleyways, and roadsides are all common areas where trash and waste materials are dumped illegally.

Materials that are often dumped illegally include household garbage, yard waste, appliances, tires, furniture, and hazardous materials such as batteries, paint, antifreeze, and biological wastes. When these materials are left exposed to the elements, the pollutants can reach waterways when rain washes through the dump site. Illegal dump sites can be a significant source of pollution in Gwinnett County's streams and lakes.

This pollution can be managed, of course, but not without the assistance of all Gwinnett County citizens, including you. If you see or know about illegal dumping activity, please report it to the Gwinnett County Solid Waste and Recycling Call Center, 770.822.7141. Staff from the Solid Waste and Recycling Division and officers with the Police Department's Quality of Life Unit will follow up on all reports of illegal dumping.

PUBLIC SAFETY

Home heating safety

Cold weather means an increase in the number of structure fires. Many of these fires are caused by poorly maintained heaters or heaters placed too close to combustibles.

If you use space or portable heaters, allow three feet of open space around the heater. Turn the heater off anytime you leave your home.

Only use a fireplace or wood stove that has been installed properly and annually cleaned and inspected by a certified professional. Never use a range top stove or an oven as a heat source. Not only is this a safety hazard, it could also be a source of fire and toxic fumes such as carbon monoxide.

SPLOST

Last Sugarloaf Parkway link gets underway

Gwinnett commissioners awarded a construction contract in November to build the final leg to extend Sugarloaf Parkway to State Route 316. It's the last of four contracts to build the first phase of a new, four-lane roadway from the previous end at State Route 20 south of Lawrenceville to SR 316 in Dacula. When completed, the new road will have interchanges at New Hope Road, Martins Chapel Road, Campbell Road, and State Route 316.



The project will improve mobility in central and eastern Gwinnett, relieving congestion by providing an additional alternative between south Lawrenceville and Grayson and the Dacula area. A planned second phase will extend Sugarloaf Parkway from SR 316 to Peachtree Industrial Boulevard to improve access between the Lawrenceville/Grayson area and the Suwanee/Sugar Hill/Buford area.

ER Snell Contractor, Inc., of Snellville was the lowest of eight bidders at \$14,799,271. The project is funded by the 2009 Special Purpose Local Option Sales Tax Program.

Work on the first section of the extension began in late 2007 and opened to traffic last February. The second section began construction in late 2008 and is on schedule to be complete by the end of 2010. Section 3A, from Martins Chapel Road to Campbell Road, began construction in early 2010 and is on schedule to be complete by mid-2012.

Protect your family with a flu shot

Flu season is here and the Gwinnett, Newton, and Rockdale County Health Departments want to remind you to get your flu shot. Flu shots are available to everyone six months and older at your local health department, pharmacy, walk-in clinic, or from your doctor.

This year's flu vaccine includes three different flu viruses: H3N2, influenza B, and H1N1.

Pneumonia shots are also recommended for people over 65 or with a chronic illness or weakened immune system.

You can also reduce your risk of getting the flu by following a few simple steps:

- Wash your hands often with soap and water or an alcohol-based hand cleanser
- Avoid touching your eyes, nose, or mouth
- Stay home when you're sick
- Do not share eating utensils and other personal items
- Cough or sneeze into a tissue or your sleeve
