Drop off your Christmas tree for recycling

Gwinnett Clean and Beautiful, in partnership with Gwinnett County, will host the annual *Bring One for the Chipper* event. When the holidays are over, drop off your live Christmas tree from December 26 to January 18 to be recycled at various locations in Gwinnett County. These trees will be chipped into mulch and used for County parks, facilities, etc. Visit www.gwinnettcounty.com for a list of locations. Fire stations will accept trees 24-hours-a-day and other facilities will accept them during their normal business hours.

Unless you have a yard waste contract with your hauler, please note that trees will not be collected curbside. Christmas Day and New Year's Day are trash and recycling holidays in unincorporated Gwinnett County, therefore collections will be delayed by one day after the holidays. Water and sewer rate increase

Effective January 2014, a rate increase will be implemented and will remain in effect through December 2014. For a complete list of rates and charges, call 678.376.6700 or visit www.gwinnetth2o.com.

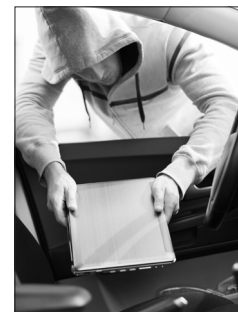

All irrigation and builder accounts will be billed at two times the tier-one volumetric rate for all water that passes through the water meter per billing period. The monthly availability charge will not change.

Be safe while shopping during the holidays

The Gwinnett County Police Department will activate its Holiday Task Force beginning Thanksgiving night and continuing every Friday, Saturday, and Sunday through December 31. In addition, officers from the Crime Prevention Unit will be conducting vehicle safety checks during the holidays, encouraging shoppers to do their part to prevent property theft.



As you are out shopping for gifts during the holidays, the Police Department wants to remind you to be safe with these helpful tips:

- Observe your surroundings; report any suspicious activity or loitering to the police.
- Store packages in your trunk and park your vehicle in a well-lit area.
- Don't shop alone and when offered, let retail employees assist you with taking your merchandise to your vehicle.
- Don't carry large amounts of cash; use secure forms of payment such as a credit or debit card when shopping.
- Have merchandise delivered to a secured location when possible.

SPLOST

County installs more cameras to manage traffic congestion

Ten more miles of fiber-optic cables will soon connect traffic cameras and signals on Gravel Springs Road and Dacula Road to Gwinnett's award-winning Traffic Control Center. The ComTran Group Inc. was the low bidder on two contracts awarded in November by the Board of Commissioners. Both projects are funded by the 2009 SPLOST program.

The Gravel Springs Road/State Route 324 project will install 10 cameras and 5.7 miles of fiber-optic cable and provide connectivity to nine traffic signals along the corridor from State Route 20 to Dacula Road at a cost of \$702,484.

The second project will install six cameras with connections to nine signals and cable along 4.5 miles of Dacula Road from Winder Highway/State Route 8 to Auburn Road/State Route 324 at a cost of \$419,656.

District 4 Commissioner **John Heard** said, "This is another good example of using SPLOST funds to improve mobility. These projects will provide more real-time traffic monitoring and control in this growing area of the county."



County offices closed Christmas, New Year's

All Gwinnett County government offices, with the exception of those operations required for the comfort and safety of residents, will be closed December 24 and December 25 for the Christmas holiday and reopen on December 26. Offices will also be closed January 1, 2014, for the New Year's holiday and reopen January 2, 2014. A Magistrate Court judge will be available at the Gwinnett County Detention Center during the Christmas and New Year's holidays.

AROUND GWINNETT

Chairman Nash presents proposed 2014 budget

Gwinnett Commission Chairman Charlotte Nash formally presented a proposed \$1.5 billion budget for fiscal year 2014 to the Board of Commissioners during a briefing on November 19. After a public hearing and period for public comment, commissioners will vote on the budget proposal on January 7, 2014, during their first meeting of the year.

The budget proposal holds the line on property taxes while expanding the delivery of emergency medical services, addressing the issue of employee retention and recruitment, and funding the impact of legislation and other external factors. The budget also preserves core services and absorbs a nearly 10 percent increase in health care costs.
