Commissioners approve cut in millage

The Gwinnett County Board of Commissioners recently lowered the millage rate for the County's general fund for 2018 to 7.209 mills, a reduction of 2.58 percent less than the 2017 millage rate.

The annual millage rate and individual annual property assessments determine each property owner's property tax for County operations. Property tax bills also include school taxes, which are usually the larger portion of the total. For properties within certain cities, the tax bill may also include city taxes. A mill is one dollar of tax for every \$1,000 of assessed property value; however, applying various homestead exemptions will reduce a residential property's tax bill.

The 2018 total property tax millage rate for unincorporated Gwinnett County will be 13.319, as compared to 13.51 for 2017. The millage rates for special service districts and countywide levies for voter-approved debt and recreation all remain unchanged from last year. Millage rates for service districts in Gwinnett are based on property location and County services provided, such as police, fire, and emergency medical. Gwinnett County Transit kicks off pilot for door-to-door bus service in Snellville

Gwinnett County Transit is launching a pilot program on September 17 that will provide six months of free door-to-door bus service in Snellville. The program will roll out over the next 20 years to seven different areas of the county.

The on-demand service will use seven 12-passenger buses operating Monday through Saturday. Riders can request service by using an app that will also show the bus's location and estimated arrival time. The service is accessible to everyone and can be used for appointments, shopping, visits, and connecting with GRTA buses going to downtown Atlanta. For more information, visit www.gctransit.com.

Gwinnett County, United Way of Greater Atlanta to explore reducing homelessness

The Gwinnett County is partnering with United Way of Greater Atlanta to address homelessness in our community by contributing \$50,000 to cover half the staff cost of a new full-time position to lead the effort. The funding for this agreement comes from \$500,000 allocated in the County's 2018 budget to address issues of homelessness in the community.

Gwinnett Library expands genealogy resources with new databases

Commissioners approve contract to renovate Norcross Senior Center

The Norcross Senior Center soon will undergo renovation with additional space and amenities to make the facility more comfortable and convenient for Gwinnett's aging population to use.

Updates at the center located at 5030 Georgia Belle Court include an improved entrance, a new covered drop-off area, and interior renovations, such as modernized restrooms, new furnishings and furniture designed to meet seniors' needs, and dining room upgrades.

Additional space will allow for new and expanded programming like art, sewing, and writing classes as well as cooking demonstrations and gardening. The \$974,000 project is funded with SPLOST revenue. Read more about SPLOST-funded projects at www.GwinnettSPLOST.com.

Fire and Emergency Services offers free home safety surveys for seniors

The Department of Fire and Emergency Services offers a free home inspection program for seniors, called SeniorBSafe, aimed at reducing the number of injuries and deaths among Gwinnett's older population.

As part of the program, fire service professionals and community volunteers team up to visit homes where seniors live to conduct safety surveys and answer questions about potential fire and life safety hazards. During home surveys, fire service personnel check and/or install safety equipment such as smoke alarms, motion lighting, carbon monoxide detectors, smart burners, and a file of life.

About 2,000 people die in U.S. residential fires annually, according to the Consumer Product Safety Commission. About two-thirds of all deadly residential fires occur in homes with no smoke alarms or no working smoke alarms.

Maintain your neighborhood detention ponds to save money, avoid flooding

When was the last time you took a walk around your neighborhood's detention pond? If it's been a while, you may want to consider a quick inspection of the pond and its infrastructure. Maintenance responsibility rests with the owner, which could be a homeowners' association, a business, or an individual.

Detention ponds temporarily detain stormwater runoff, which improves water quality in streams and lakes by slowing down the flow from streets, neighborhoods, parking lots, commercial areas, and industrial sites. The detention of the water allows sediment to settle out, reducing pollution and sedimentation of streams. Regular inspections and maintenance can save money and avoid potential flooding problems later. Poorly maintained ponds fail to protect water quality and prevent bank erosion. They can also harbor nuisances.

Inspect your detention pond every three or four months and after significant rainfall to spot small issues before they become big problems. Examine all the major structures, including the dam, the pipes draining water into the pond, and the outlet control structure, which releases water from the pond. They should be regularly checked for cracks, depressions, holes, tree growth, or other signs of failure. Watch for erosion as well, and keep your detention pond and the access easement free of debris, shrubs, and trees.

If you have an escrow account, your property tax information is available to your mortgage company; however, it is your responsibility to ensure taxes are paid.
