Commissioners approve expansion of Infinite Energy Center, boost for tourism

The Gwinnett County Board of Commissioners recently took several steps to enhance tourism and support the expansion of the Infinite Energy Center.

Commissioners authorized Explore Gwinnett, formerly known as the Gwinnett Convention and Visitors Bureau, to receive a portion of the County's hotel/motel tax to promote tourism, conventions, and trade shows. The board also raised the County's hotel/motel tax rate to 8 percent effective August 1 in the first increase in 18 years.

Two years ago, the Board of Commissioners endorsed the master plan for the Infinite Energy Center campus. Voters then approved \$67.3 million in 2017 SPLOST funding to expand the center. Plans call for an expansion of the exhibit hall, more parking, a hotel, more arena seating, and a mixed-use district with entertainment, dining, retail, and housing.

The commissioners also set terms for issuing bonds for construction, the County's first construction bond issue in nearly 10 years.

The Infinite Energy Center, located at 6400 Sugarloaf Parkway, provides \$200 million in economic impact annually.

Gwinnett to offer free disposal of household hazardous waste on August 11

Household hazardous waste materials can potentially contaminate water resources and pollute the air.

To help protect the environment and ease the burden on Gwinnett residents, the County's Fiscal and Solid Waste Management Division, Department of Water Resources, and Gwinnett Clean & Beautiful are partnering to host the County's first household hazardous waste recycling event on **August 11**. Gwinnett residents can drop off five containers each of household hazardous waste for free.

The event is limited to Gwinnett residents and proof of residency may be required.

Materials accepted at the event include cleaners, batteries, fluorescent light bulbs and ballasts, lawn care products, oils, paints, and pesticides.

The event runs from 9:00am to noon at the Department of Water Resources Central Facility at 684 Winder Highway in Lawrenceville. For a full list of acceptable items, visit www.gcsolidwaste.com.

New solid waste agreement offers larger recycling containers for free

The Board of Commissioners has approved a revised agreement with residential solid waste haulers that allows residents in unincorporated Gwinnett to keep the same services for less money and makes it easier to recycle more.

Residents can contact their hauler to request a covered 65-gallon recycling cart on wheels at no additional cost. To identify your hauler, please visit www.gcsolidwaste.com. Recycling carts requested in July will be delivered no later than September. Recycling carts requested after July will be delivered within 60 days.

The monthly fee for basic solid waste is being reduced from \$19.16 to \$17.91, and the rate for those individuals who are age 62 and older is being reduced to \$13.75 with no reduction in service.

County partners with state to fund Interstate 85 corridor study

The Gwinnett County Board of Commissioners recently committed to providing \$5 million over the next four years to cover half the cost of studying the Interstate 85 corridor.

Georgia Department of Transportation will fund the other half of the study to extend I-85 from I-285 to I-985. Gwinnett County's portion is funded by the 2017 SPLOST.

The project was identified in the County's Comprehensive Transportation Plan.

The study will address congestion, improving traffic flow, and safety. Georgia DOT will manage the project, with a total cost not to exceed \$10 million. For details on this and other SPLOST-funded projects, visit www.GwinnettSPLOST.com.

New distracted driving law takes effect July 1

Under a new law, motorists can no longer physically hold a phone, GPS navigation device, media player, tablet, computer, or other electronic device while operating any vehicle. The law also prohibits reading or writing text messages, recording or playing videos except for hands-free devices such as dash cameras that record continuously, and sending or receiving internet data.

Drivers can still talk on the phone or use voice-to-text technology if done through an earpiece, headset, smart watch, or other hands-free device. Phones and other devices may also be used for navigation if mounted and used hands-free.

Violators face a fine of \$50 and 1 point on their driver's history for a first offense; a \$100 fine and 2 points for a second offense; and a \$150 fine and 3 points for a third offense. Motorists may receive a one-time pass for a first offense if the driver appears in court with proof of having purchased a hands-free device.

Gwinnett Police estimate that in 2017, 1,088 collisions were related to distracted driving, resulting in 2,254 citations.

Septic tank maintenance saves money, the environment

If you have a septic tank, the best way to avoid costly and foul backups into your home and discharges into streams and lakes is to understand how your septic system works and how to properly maintain it.

Septic systems hold wastewater in an underground tank where solids settle to the bottom. A pipe at the top of the tank takes wastewater and runs it into an absorption field, or drainfield, a series of perforated pipes or chambers buried in the yard. The drainfield allows the wastewater to slowly infiltrate the soil, which is the last step in the treatment process.

Regular maintenance will prevent failures and extend the life of your system. A properly maintained septic system can last for more than 30 years. These tips will help keep your system up and running, and help you avoid expensive replacement of the drainfield or the tank:

- · Have your septic tank pumped out every three to five years
- Flush only human waste or toilet paper
- Use cleaning chemicals as directed. In excess, these chemicals can harm the septic system
- Spread washing machine use throughout the week. Doing all your household laundry in one day could flood your drainfield
- Don't plant trees over or near your drainfield
- Remember that septic system maintenance is proactive; don't wait for your septic system to fail before you have maintenance performed
