Proposed Gwinnett 2023 budget totals \$2.26 billion

Commission Chairwoman Nicole Hendrickson's proposed budget for 2023 totals \$2.26 billion. The proposed budget consists of a \$1.8 billion operating budget, which funds everyday expenses such as employee salaries, benefits, equipment, and repairs, and a \$488 million capital improvements budget, which includes funds from the County's Special Purpose Local Option Sales Tax program.

New initiatives to be funded by the operating budget include enhanced staffing for the County's Emergency Management division, a new language learning program for employees, new Environmental Sustainability Officer and Equity Officer positions, and staff to support the new seventh State Court judge added by House Bill 1570 earlier this year. The capital budget will pay for new roads, parks, and libraries.

The proposed 2023 budget resolution is available at GwinnettCounty.com. Residents can also share comments on the County's website through December 31. Commissioners will consider the budget January 3.

Recycle your live Christmas tree after the holidays

Want to be sustainable this holiday season? Between December 26 and January 25, drop off your live Christmas tree at designated fire stations as part of the annual Bring One for the Chipper event! On January 28, Gwinnett Clean & Beautiful will chip the trees into mulch for use at County parks. The designated Gwinnett fire stations will accept trees 24/7. Assessors' Office will conduct onsite property field visits

Gwinnett Board of Assessors appraisal staff conduct routine field visits to maintain accurate appraisal data as part of the County's annual review process. Representatives from Gwinnett County, LMC, or Tyler Technologies verify existing or new construction, measure exteriors, and take photographs.

Although no contact or involvement is needed, appraisers will carry identification and announce their presence at the property before beginning a review. If no one is available, information will be left to advise residents of the visit.

Winterize pipes in and around your home

While cooler weather may be a refreshing change from intense summer heat, freezing temperatures can cause damage to your plumbing, leading to leaks, wasted water, and high water bills. Prepare your pipes for frigid temperatures with these helpful tips:

- Insulate pipes in attics, basements, and crawl spaces
- Use an insulated spigot cover on outdoor faucets
- Open the kitchen and bathroom cabinet doors to let warm air in
- If you travel, leave your heat set to at least 55 degrees

TAX COMMISSIONER

Are you 65 as of January 1?

If you are 65 or older as of January 1 and your taxable income is less than \$105,280, you may qualify for the Senior School Tax Exemption. Apply online through Saturday, April 1 at GwinnettTaxCommissioner.com/Apply. Seniors must provide proof of their prior year's income to be considered for the exemption. Deck your holiday tree with these safety tips

For many, the first step in preparing for the holidays is decorating the home; however, not everyone thinks of potential fire hazards. Almost one third of home Christmas tree fires are caused by electrical problems. The following safety tips will help make the holiday season a safe and enjoyable time for the whole family:

- Choose a tree with fresh, green needles that do not fall off when touched
- Ensure the tree is at least three feet away from any heat source
- When lighting the tree, use lights that are listed by qualified testing laboratories
- Replace any string of lights with worn or broken cords or loose bulb connections
- Never use lit candles to decorate the tree

A burning tree will rapidly fill a home with superheated air and toxic gases produced by the flames and smoke. Remember to take special safety precautions when keeping a live tree in your home. To find more safety tips for the holiday season, visit GwinnettSafety411.com.



SPLOST

Residents vote to renew SPLOST

On November 8, Gwinnett voters approved the renewal of the one-cent Special Purpose Local Option Sales Tax. The six-year program – which will begin when the current program expires in April 2023 – is expected to raise \$1.35 billion for capital projects.

SPLOST helps the County keep up with the needs of our growing population and allows the County to pay for major projects with a funding source other than property tax revenue. This includes new projects and improvements to existing assets. Plans for the 2023 SPLOST program revenue include \$736.3 million for transportation, including roads, streets, and bridges; \$133.9 million for public safety projects, including a new police headquarters; and \$108 million for recreational facilities and equipment. New tool helps 911 locate callers

Gwinnett County recently launched a new geolocation tool, What3Words, to help locate E-911 callers in locations where there are no roads or specific addresses. The free What3Words app gives each 3-meter square in the world a unique three-word address. If someone is lost – especially in a park, around Lake Lanier, or in any other undeveloped natural area in the county – they can use the unique three words from the application to give dispatchers their exact location. First responders get enhanced cardiac arrest training

Every second counts when it comes to saving someone's life during a cardiac event. That's why Gwinnett Fire and Emergency Services is aiming to increase first responders' proficiency to help save the life of a heart attack victim. The department will transition to a resuscitative training that requires recertification every 90 days. The training includes CPR simulation stations, skills training, and an online component. The training also records and tracks metrics to provide focused feedback that will enhance responders' skills.
