As the first person of color and woman to be elected to the District Attorney's Office in the Gwinnett Judicial Circuit, she has made history and hopes to inspire the next generation of young people.

With a distinguished career spanning 34 years, D.A. Austin-Gatson possesses extensive expertise in both criminal and civil law. She began her legal journey at the Attorney General's Office of Georgia, and serving as a law firm associate. In 1992, D.A. Austin-Gatson founded her esteemed law firm, Austin & Associates, that specialized in criminal, family, and civil rights employment cases.

Prior to assuming the role as District Attorney, she held the Supervising Attorney role in the Gwinnett County Solicitor's Office. In this capacity, she effectively managed records restrictions and oversaw a team of twenty-five staff members, embodying a leadership style grounded in the principles of justice, fairness, and accountability.

D.A. Austin-Gatson is an alumna of Emory University School of Law and holds a Bachelor of Science degree from Syracuse University School of Human Development. Her formative legal experiences include internships with the Federal Trade Commission and work with the Brooklyn District Attorney's Office.

A central principle of D.A. Austin-Gatson's priorities is restorative justice to mitigate recidivism and address mass incarceration. Her vision extends to ensuring the safety of Gwinnett, providing second chances, safeguarding victims, and implementing preventative measures to deter young individuals from entering the criminal justice system.

Beyond her legal pursuits, D.A. Austin-Gatson actively participates in volunteer initiatives, contributing to causes such as the Berkmar High School Young Litigators, Red Cross relief efforts following Hurricane Katrina, Hospice Care, a Peru Mission Trip, and the Greater Eastside Chamber of Commerce feeding program.

Family holds a special place in D.A. Austin-Gatson's life. As the youngest of six siblings and a resident of Gwinnett County for 25 years, she and her husband, Travis Gatson, have raised three children and take pride in being grandparents to four grandchildren.

In her personal life, D.A. Austin-Gatson finds joy in reading and traveling. Her well-rounded background, unwavering commitment to justice, and dedication to fostering positive change make her a prominent figure in the legal community and a role model for aspiring individuals.

GWINNETT NAMED 2022 GEORGIA CHILD FATALITY REVIEW COMMITTEE METRO COUNTY OF THE YEAR

On October 27, 2023, Gwinnett was recognized as the 2022 Georgia Child Fatality Review Committee Metro County of the Year for its data collection efforts to help prevent child deaths in the county. The award was presented by the Georgia Child Fatality Review Panel with the Georgia Bureau of Investigation. The award reflects the work done by the Gwinnett County Child Fatality Review Committee, which is led by the Gwinnett County District Attorney's Office and Victim Witness Program.

Every county in Georgia has its own Child Fatality Review Committee that meets within 30 days of a child's death to gather and submit its findings.

The Gwinnett County Child Fatality Review Committee was honored for submitting quality, comprehensive reports while collaborating with other agencies that review each child-related death from ages 0 to 17. These reports prompt discussions that lead to preventative strategies to reduce child deaths.

GWINNETT COUNTY LEAD ACADEMY

Congratulations to our outstanding employees who successfully completed the LEAD Academy in 2023! The LEAD Academy is a comprehensive program developed to support Gwinnett County supervisors. The academy serves as the cornerstone for management development within Gwinnett County Government.

This three-month program is meticulously crafted to integrate the County's culture, expectations, policies, and procedures into its curriculum, fostering a results-oriented approach. The acronym LEAD encapsulates the essence of the program—Leadership, Education, and Development—reflecting its commitment to equipping County leaders with practical skills and ethical knowledge.

JURY TRIALS

The Gwinnett County District Attorney's Office focuses on building strong cases, conducting thorough investigations, and working with law enforcement to ensure individuals charged with criminal offenses are prosecuted fairly and justly. We aim to achieve convictions, uphold the law, and provide a sense of security and justice to the community.

- The Gwinnett County District Attorney's Office tried cases effectively throughout 2023.
- This rate has increased since District Attorney Patsy Austin-Gatson took office and implemented her own staff.
- The District Attorney's Office prosecutes hard cases and permits the Jury System to render its verdict.

14 SEX CRIME TRIALS RESULTED IN AN 82% CONVICTION RATE

SPECIAL VICTIMS UNIT

The Gwinnett County District Attorney's Office Special Victims Unit handles cases involving sensitive crimes such as sexual assault, child abuse, domestic violence, and other related offenses. The SVU works closely with law enforcement, victim advocates, and other agencies to investigate and prosecute these cases. Its primary goal is to seek justice for victims while supporting them through the legal process. Additionally, they provide resources and support to the community, such as education on preventing these types of crimes and offering assistance to survivors.

- District Attorney Patsy Austin-Gatson expanded her Special Victims Unit since taking office. The SVU is now comprised of a team of prosecutors that have expertise in these cases.
- The SVU conviction rate is higher than national averages due to the hard work of the unit.
- The SVU ensures each victim is heard and respected so that no matter the outcome of the trial, victims and their family know District Attorney Patsy Austin-Gatson cares about them.

11 DRUG AND GANG CASES RESULTED IN A 90% CONVICTION RATE

DRUGS AND GANG TASK FORCE

The Gwinnett County Drugs and Gang Task Force specializes in combating drug trafficking and gang-related issues. They investigate and prosecute cases involving drug distribution, trafficking, and the illegal sale of controlled substances. Moreover, the task force targets gangs involved in criminal activities like drug trade and violence, collaborating with law enforcement to disrupt drug networks and gather intelligence for dismantling gangs. Through a mix of law enforcement strategies, community outreach, and education, its mission is to lower drug-related crime rates, enhance neighborhood safety, and curb the influence of gangs, ultimately safeguarding the community from these detrimental effects.

- Drug addiction continues to be a concern in our community. To that note, District Attorney Patsy Austin-Gatson has ensured that her Drug and Gang Task Force is staffed with experienced prosecutors and investigators that are knowledgeable about local gang activity.
- Drug and gang activity contributes to overall violence, so aggressive prosecution of drug activity helps to keep Gwinnett safe.



INITIATIVES

CITIZENS ACADEMY

The Gwinnett District Attorney's Citizens Academy is designed to create a better understanding of the criminal justice system. The academy is a nine-week program that immerses residents in the judicial process. Sessions bring the community together with law enforcement, prosecutors, and judges, as the local criminal justice system is far more complex and diverse than most know. With this academy, we aim to show the role of the District Attorney's Office and our processes to create a more informed and enlightened community. Residents will be able to watch court during the week for a better understanding of the justice system.

The program begins with an insightful overview of prosecution challenges and specialized areas, addressing topics such as Victim Witness, Special Victims Unit, Drug & Gang Task Force, and Juvenile Prosecution. This gives residents an opportunity to learn about drug trends and gang prosecutions. Furthermore, the program provides a deep understanding of the American legal system, enforcement agencies, and court structures.

Academy sessions detail the legal process, constitutional rights, on-scene investigations, and ethical considerations. One unique aspect involves a visit to the Gwinnett County Police Department for an in-depth overview of Crime Scene Investigation techniques. Participants benefit from prosecutors' analysis of a criminal trial by enhancing their comprehension of SVU cases. The program incorporates discussions on evidence law, ethical practices, and a session on understanding the use of force and jury nullifications.

- The Gwinnett County District Attorney's Office purchased the Leica machine for our policing agencies to use with the aim of enhancing case prosecution capabilities.
- In an effort to strengthen the prosecution of Special Victims Unit (SVU) cases, the District Attorney's Office purchased the Colposcope machine by Cortex Flo for Mosaic Georgia to prosecute sexual assault cases.

JUNIOR DISTRICT ATTORNEY AND INVESTIGATOR MENTORSHIP PROGRAM

The Junior District Attorney and Investigator Mentorship Program affords participants a hands-on experience in understanding the practical applications of the criminal justice system by exploring the roles of the court, law enforcement, and corrections. Participants receive training in law, self-discipline, and a multitude of life skills while working directly with assistant district attorneys, investigators, and administrative staff.

The District Attorney's Office launched its first Junior District Attorney and Investigator Mentorship program in 2022 with just 12 students from our local High Schools. In 2023, the program grew by 308% and graduated 49 participants.

WE STRIVE TO EDUCATE, NOT INCARCERATE

REHABILITATION ENABLES DREAMS PROGRAM (RED)

RED program is a partnership between the Gwinnett County District Attorney's Office and Rehabilitation Enables Dreams, a Georgia domestic 501(c)3 nonprofit restorative justice organization based in Atlanta, dedicated to keeping non-violent offenders out of the criminal justice system. The 12-month Pre-Adjudication Restorative Justice Program enhances the social, civic, financial, and digital literacy of individuals referred to court. RED's evidence-based digital curriculum equips participants with the soft and hard skills necessary to leave the criminal justice system and reenter society as thriving members of their community.

Participants are given laptops at our program orientation that allows them access to our cloud-based digital curriculum. Peer forensic mentors are matched with program participants during the second month of the program and remain actively engaged through graduation. Our social, civic, and financial literacy modules include:

Emotional intelligence training

- Financial planning
- Proper police-citizen encounters
- Career readiness

Voting procedures education

Each month, program participants join a pro-community outing that is relevant to the subject matter. In addition to our digital curriculum, classroom sessions, pro-community events, and mentor support, all participants who do not have a high school diploma are enrolled into our GED Certification Program and are given access to immediate and long-term employment opportunities.

RYZER PROGRAM

Ryzer has partnered with the Gwinnett County District Attorney's Office to offer a six-month pre-trial diversion program. This program educates youth in the juvenile justice system and nonviolent offenders on positive behavioral, emotional, and social skill-building to strengthen their capacity in the community and prevent future return to criminal court. It aims to address risk factors that make adolescents more susceptible to developing violent behavior such as social or cognitive problems, association with peers who are violent, beliefs that support the use of violence, and academic failure or poor commitment to school. The goal of the Ryzer Intervention Program is to enhance individuals' awareness of the consequences of their attitude, decisions, and emotional state, promote improvement of behaviors to help prevent them from entering the juvenile justice system, and avoid further problems. The program also aims to make youth feel more positive, cheerful, and optimistic about their current situation and outlook.

The first 12 weeks of the program consists of one-hour sessions with modules. The second 12 weeks consist of a follow-up and limited module work as needed. Curriculum modules provide participants an opportunity to engage with family and community and delve into research and presentations. Curriculum modules include:

- Family tree exercises
- Getting to know you
- Emotional awareness and anger management Understanding law enforcement
- Coping mechanisms
- Budget and finance
- Time management
- Positive affirmations

- Understanding your potential
- What is your purpose?
- Setting and achieving goals
- Think sheet behavior contract.

Program participants are provided mentors during the program to assist in their success. We are proud to have graduated two cohorts.

SUPPORTING OUR VICTIMS

VIRTUAL HOMICIDE VICTIMS SUPPORT GROUP

Our support group assists anyone who has experienced a loss due to a homicide or vehicular homicide. It may be helpful to meet with others who have experienced similar losses. Support groups provide an opportunity to share your story, encourage others, and be encouraged.

ANNUAL CRIME VICTIM CANDLELIGHT VIGIL

The Gwinnett County District Attorney's Office recognizes the profound impact crime has on individuals and communities. The annual Crime Victim Candlelight Vigil serves as a supporting gathering, offering solace, and a solemn remembrance for those affected by crime. Through this event, we aim to honor victims, raise awareness, and foster a sense of unity while emphasizing the ongoing commitment to justice and advocacy for victims through our Victim Witness program.

Since 2021, we've observed a noticeable increase in community members attending the Annual Crime Victim Candlelight Vigil, with a growing interest from a diverse range of community members eager to connect with this event.



















NATIONAL CRIME VICTIMS WEEK

The 2023 National Crime Victims' Rights Week theme was **Survivor Voices: Elevate. Engage. Effect Change**. This year's theme calls upon communities to amplify the voices of survivors and create environments where survivors have the confidence that they will be heard, believed, and supported. During this week, our Victim Witness Program organized several activities to honor crime victims and survivors.

The District Attorney's Office staff wore buttons to honor the voices of victims. We also placed theme posters on the outer hallways of the District Attorney's Office with real quotes of victims' voices, in addition to filming a public service announcement involving some of our victims and survivors of crime.
