SPLOST Referendum 2008 Joint County/City Meeting July 17, 2008



Purpose of Today's Meeting

O.C.G.A. § 48-8-111 requires the following:

- Governing authorities of the County and cities meet to discuss possible projects/ purposes for inclusion in the SPLOST referendum
- A meeting must be held at least 30 days prior to the issuance of the call for the referendum



- Qualified cities are entitled to a share of the SPLOST
- Cities are qualified if they provide at least three out of 12 services – all Gwinnett cities are qualified



- The County and individual cities receiving SPLOST proceeds must each maintain records, prepare annual audits, and publish annual reports in the newspaper
- Proceeds must be used for capital outlay projects as distinguished from current expenditures and ordinary maintenance expenses



Examples of eligible projects/purposes:

- Transportation projects which purposes may include roads, bridges, sidewalks, bike paths, stormwater, and drainage
- Recreational, cultural, and historic facilities (or combination)
- Public safety facilities and equipment
- Courthouse, administrative buildings, local or regional jail



Examples of eligible projects/purposes:

- Libraries
- Water and sewer capital projects
- County health department facility
- Retirement of general obligation debt
- Other capital projects



Georgia's SPLOST Law Options

Countywide projects

- For use or benefit of citizens of entire county
- Certain countywide projects are level one and receive funding first; SPLOST shall be five years without IGA or potentially six years; no limit on collections
- Can have 20 percent of proceeds for level two countywide projects first; SPLOST up to six years; no limit on collections



Georgia's SPLOST Law Options

- No intergovernmental agreement
 - Proceeds distributed to County and cities based on population after level one and level two projects
 - Must have purposes and estimated costs for the resolution
 - Proceeds distributed monthly



Georgia's SPLOST Law Options

- Intergovernmental agreement with cities representing no less than 50 percent of municipal population
 - Agreement must contain:
 - List of projects/purposes and estimated cost of each
 - Proceeds distribution schedule
 - Record-keeping/audit procedures
 - Agreement entered into prior to call for the referendum can be up to six-year SPLOST



2009 SPLOST PLANS

- Five year program
- Estimated amount \$850 million
- Intergovernmental agreement with all 15
 Gwinnett County cities



- County's first SPLOST
- Approved by voters in June 1985
- Purpose: Construction
 of Gwinnett Justice and
 Administration Center
- Collections: \$65.5 million 24 months (October 1985 – September 1987)
- Average monthly collection: \$2.7 million





Approved by voters in November 1987Purposes:

-Construction of Civic Center and the Pre-Trial Detention Center

 Preservation of the Gwinnett Historic Courthouse





Purposes: Road, street, and bridge projects



Ronald Reagan Parkway



- Collections: \$162.7 million 48 months (April 1988 – March 1992)
- Average monthly collection: \$3.4 million



Approved by voters in November 1991Purposes: Road, street, and bridge projects



Annistown Road Widening



- Collections: \$249.1 million 48 months (April 1992 – March 1996)
- Average monthly collection: \$5.2 million



Approved by voters in November 1996

Satellite Boulevard extension



- Collections: \$415 million 48 months (April 1997 – March 2001)
- Average monthly collection: \$8.6 million



- 11/4/08 SPLOST vote
- 4/1/09 SPLOST effective date
