

This report is being filed late due to several factors:

- 1.) I was initially told by the Elections Office that I would need to qualify with the Gwinnett GOP.
- 2.) Then I was told by the Gwinnett GOP that I would need to go to the Ethics Commission to file all forms related to any financial disclosures, commitments, etc. on the day I qualified on 3/04/2014.
- 3.) I went directly to the State Capitol to the Ethics Commission on 3/07/2014 only to be told that as of January 1st, this had changed for county positions, and I would need to go back to the County.
- 4.) I contacted and went to the GOP and asked them regarding this the same day. They were not aware of this change. They directed me to the Gwinnett Elections Office.
- 5.) I went to the Elections Office, and they informed me of the DOI and the PFD that needed to be filed within 15 days of qualifying which I did. AT NO POINT was I given a filing schedule or list of forms, etc. or even told which website to check for these forms. I was also not told of the Local Candidate Affidavit that needed to be filed at qualifying (which I think the GOP should have explained and had readily available at the time of qualifying) in order to avoid extensive reporting for a candidate that does not expect to intake or expend \$2500.00 or more. I was also not told regarding the RC Form that was needed prior to accepting campaign funds even after attending a training recommended by the GOP that I paid for it and attended it in Cobb County.
- 6.) It was not until this past Monday, April 7th, that I contacted the Elections Office to be sure I had all my requirements that I was told I had missed the deadline for filing my CCDR, and could face possible significant penalties that would exceed the little money that I have in the campaign account! They then directed me to the Ethics Commission which then directed me to a group called the ACCG that directed me back to the Elections Office since the Commission was inappropriately directing candidates to their office.

At that point, I contacted Rachel Little to see if she had a copy of an affidavit that I had signed at qualifying to be sure I had completed the much needed Local Candidate Affidavit to avoid all the additional filings. She said I had not done so at their office at qualifying. I asked why this was not part of a packet that candidates should complete at the time of qualifying, especially for FIRST TIME candidates that are just getting to know the ropes, so to speak. She responded with the email below:

Email from Rachel Little, Gwinnett GOP President, dated 4/17/2014, in response to my questions as to what I had filed at the time of qualifying & if the Affidavit of a Candidate's Intent form was not part of that:

"I understand your frustration and share it. Unfortunately, since this seems to be a new requirement, no one told me either. I'm a new chairman and rely on the State GOP to provide me with what I need and this was not part of their qualifying packet either. I suspect they weren't told by the State Ethics Board that this had changed. I do wonder why the Ethics Board didn't tell you this info when you went downtown during qualifying week? The qualifying "packet" and forms you get from the party are what the Party requires for you to be allowed to be on our ballot. The ethics filings/requirements are a State of GA requirement."

Due to the above factors, I would request of the Commission that I be released from the possible penalties associated with late filing due to the significant amount of confusion among the 3-4 offices listed above, especially since this is my first time as a candidate, and others have expressed similar confusion with the very recent changes in the law.
