Mission

Gwinnett County Recorder's Court mission is to create a positive image to the defendants, witnesses and attorneys, as well as other departments, in order to effectively provide justice in a prompt and courteous manner.

Recorder's Court

Handles traffic citations issued by:

- Gwinnett County Police Department
- Gwinnett County Sheriff Department
- Georgia Department of Driver Services
- The Department of Transportation
- Gwinnett County School Police
 - School Bus Camera Violations (Redflex)

Recorder's Court

Handles Gwinnett County Code Violations such as citations issued by:

- The Gwinnett County Animal Welfare and Enforcement
- The Planning and Zoning/Inspection Department
- The Business License Department
- The Environmental Health Department

Overview

Recorder's Court is divided into three offices:

- The Judicial Office
- The Prosecutorial Office
- The Clerk's Office

Judicial Staff

The Judicial Staff consists of 15 employees:

- 3 Judges
- 3 Judicial Assistants
- 3 Calendar Coordinators
- 6 Part-time Bailiffs

Explanation of Increase

- \$90,000 requested for remote arraignment video equipment funding
- •\$99,412 increase in direct cost allocations

Remote Arraignments

- This request will reduce the cost to transport in-custody defendants from the Detention Center to Recorder's Court for Arraignments
 - According to Sheriff's study conducted three years ago, transporting each in-custody defendant requires 40 deputy man hours

Remote Arraignments (continued)

 Recorder's Court requires the appearance of approximately 195 in-custody defendants per month, requiring about 7800 man hours

Remote Arraignments (continued)

 Using an extremely conservative estimate of deputy compensation at \$10 per hour, our request for \$90,000 for remote arraignment equipment funding would pay for itself in less than a month

Remote Arraignments (continued)

• Additionally, fuel and maintenance costs for the five weekly round trips would be eliminated

Remote Arraignments (continued)

- Successful implementation of this request will also increase safety for Sheriff's staff
 - Individuals facing serious charges in other courts can be arraigned on our charges while remaining secure in the Detention Center



School Bus Revenue


School Bus Camera Projections

Citations Revenue




Citations Filed by Year
