State Court Attorney Position

Responsibilities:

- Prepare cases for trial or resolution
- Review body worn cameras and other evidence
- Communicates with witnesses and victims
- Negotiate with defense attorneys and Pro Se defendants
- Attend court appearances:
 - Arraignments, Trial Calendars, Motions, Probation Revocations

Justification:

- Judicial emergency
- Backlog of cases
- Judges running multiple courtrooms at the same time
- Body worn cameras
- Continued DUI litigation in Supreme Court and CoA equals increase in hearings at trial level
- Increase in population and law enforcement officers



Intake/Jail Division Attorney Position

Duties/Responsibilities:

- Decide appropriate charges based on the evidence
- Use discretion to identity cases that should or should not be prosecuted
- Review for felony charges
- Conflict cases
- DUI Court

Justification:

- Sheer volume of cases requires the attention of more than one full-time attorney
- Reduce/prevent backlog
- Early identification of cases appropriate for Mental Health and Veterans' Court
- Early identification and consolidation of defendants with multiple active cases
- Identify cases appropriate for Fast Track
- Safer community



Criminal Investigator Responsibilities

- Arrest powers
- Review each of the 7,664 cases that are assigned to State Court per year
- Locate and subpoena witnesses
- Real-time services to attorneys while they are in court
- Locate and obtain evidence
- Draft and serve search warrants
- Partner with other LEOs to assist in special details

Two Criminal II Investigators

Jail Division

- Our Jail Unit services defendants who remain in custody
- 2,283 State Court Cases are originated out of the jail
- One Full Time onsite Investigator can expedite the cases
- Will reduce the Detention Center population
- Gather information prosecutor can use for court appearance

Intake Division

- Investigates law enforcement and civilian warrants, Municipal and Recorder's Court bind overs
- 5,381 cases originated in Intake Unit in 2019
- Ensure all reports and evidence are collected for each case
- Reduce time for case to appear on a court calendar
- Ensures efficient and speedy resolution of cases in court
- Save County money
- Investigate Fast Track cases



IT Associate II

- The Solicitor's Office employees are housed in multiple locations:
 - GJAC
 - Courthouse Annex
 - Detention Center
 - Home users
- Additional equipment for telecommuting
- Training
- Older, leased desktops need extra attention
- New laptops require setup and deployment
- Increased workload due to pandemic



Legal Associate II – Recorder's Court Division

Responsibilities:

- Prosecute traffic cases and ordinance violations
- Prepare 42 calendars a <u>WEEK</u>
- Support five attorneys
- Collect evidence, create subpoenas, prepare discovery, answer phones and help the public
- Critical position for efficient, effective and equal justice

Justification:

- New school zone speed enforcement calendars
- New online court preparation
- New attorney position
- Increase in defense filings
- Judicial emergency
