Rule 3.8: Special Responsibilities of a Prosecutor (Comment)

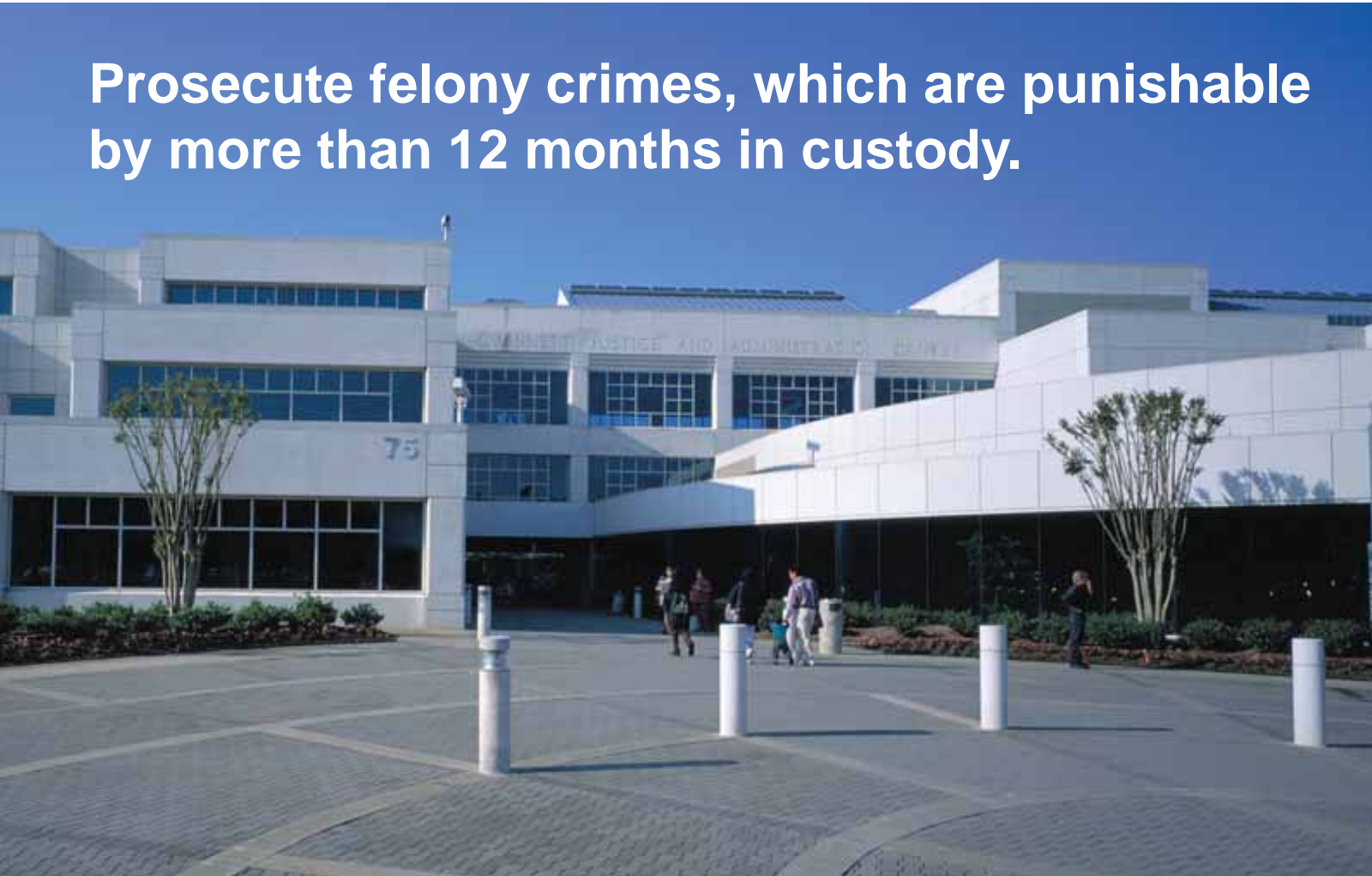

Prosecute felony crimes, which are punishable by more than 12 months in custody.

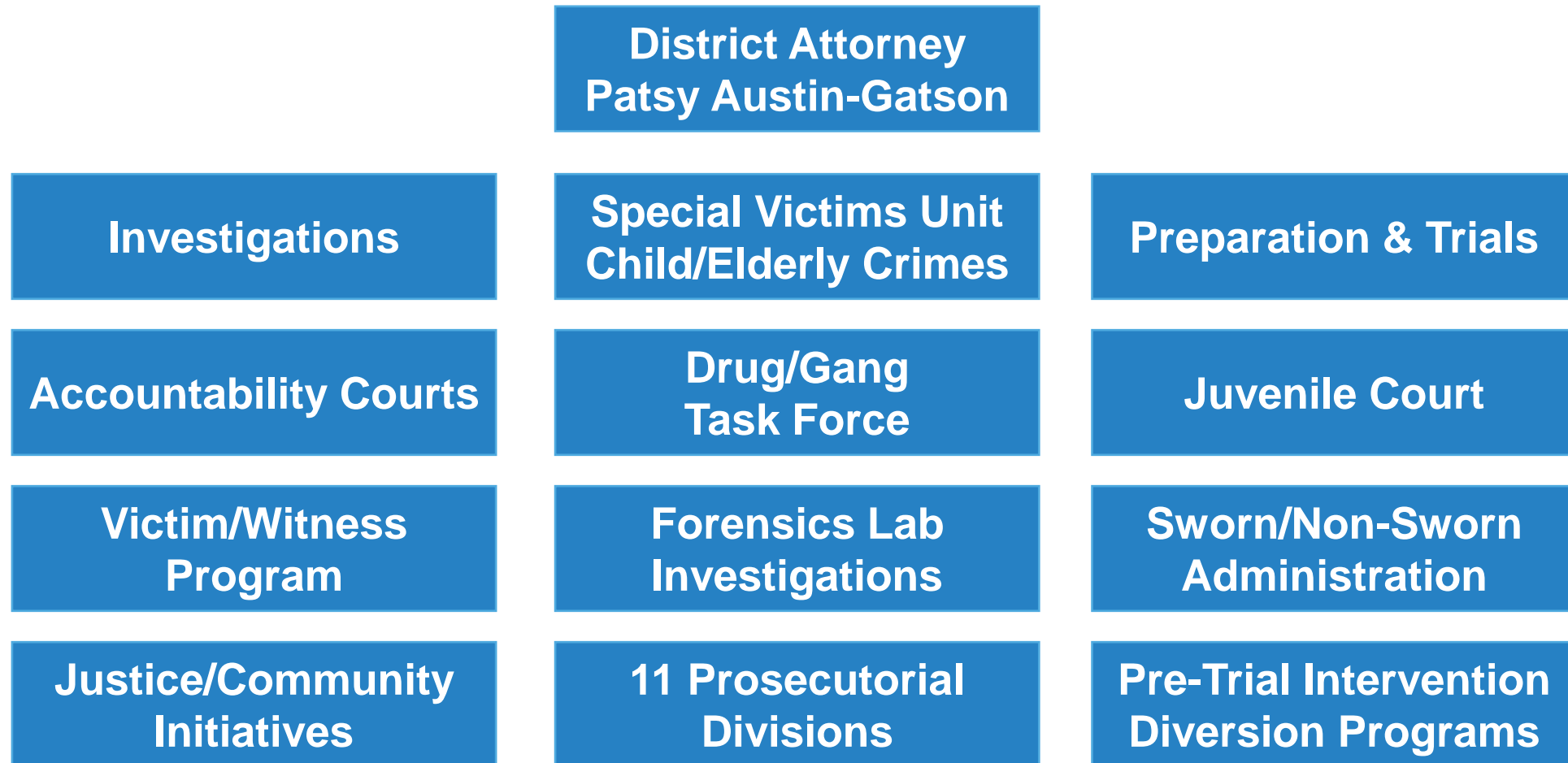


TYPES OF CASES PROSECUTED

Year to Date Recap: Accomplishments

- **New Administration and an inclusive and diverse staff who engaged in the first Implicit Bias training in the District Attorney's Office**
- **Commencement of jury and bench trials on April 19, 2021**
- **Entered a Memorandum of Understanding between DA's Office and a restorative justice program for 17 to 28-year-old defendants**
- **Established a pilot DA pre-trial intervention in Juvenile Court**

- **COVID-19 pandemic workflow restructuring**

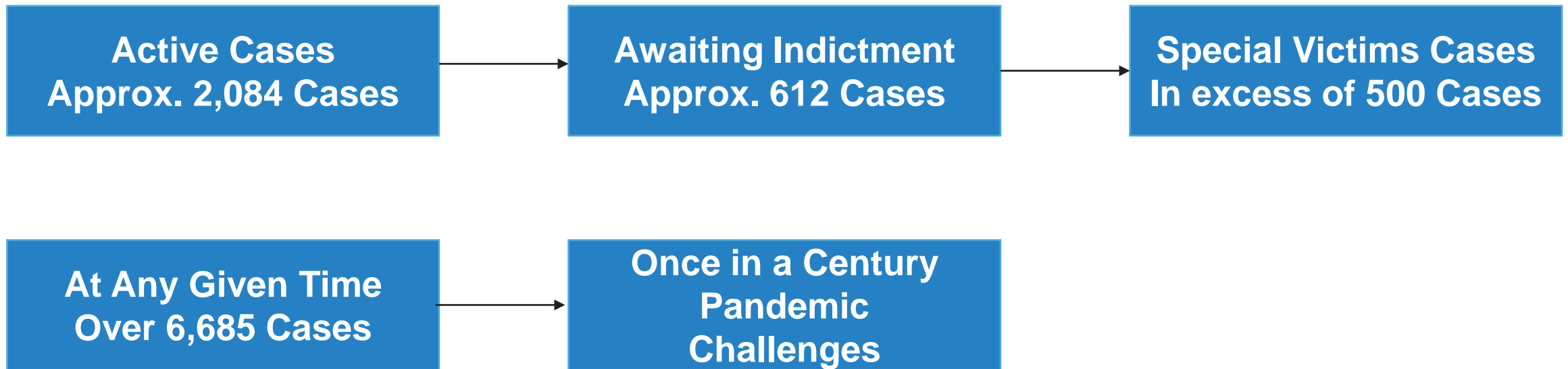


Year to Date Recap: Challenges (Opportunities)
