2023 YTD Recap

Accomplishments

- 53 jury trials resulting in an 80% conviction rate.
- 96% of our cases were affirmed on appeal, meaning the Appellate Court ruled in our favor.
- Junior District Attorney/Investigator Mentorship Program grew from 12 students to 49, which is an increase of 308%.
- Prosecuted four Fentanyl cases, which resulted in murder and voluntary manslaughter convictions. Ten cases are still pending.



2023 YTD Recap

Challenges

- Office space not sufficient for the needed number of employees
 - Even considering future office moves, the space is insufficient as the office will still be in multiple locations
- In the 11 court divisions that we service, several periodically run double courtrooms
- Not having the adequate amount of ADA positions to service Gwinnett's growing population in 2024, which is estimated to be 1,008,402
