#### Residential Appraisers I-IV (4)

- The Residential Appraisers will be responsible for conducting field visits, entering property data, and representing the County at any subsequent appeal hearings.
- Requested Budget \$437,649





- Provide residential property valuation efforts
- Reduce parcel-to-appraiser ratio and expand field review coverage



#### Program Analyst II (2)

- The Program Analysts will be responsible for building dashboards, automating workflows, and supporting the rollout of tools such as tablets, field audit apps, and internal testing platforms to improve data collection, administer the annual County tax digest, and provide accuracy and transparency.
- Requested Budget \$222,244





- Provide technological integrations

#### Commercial Appraiser I-IV (1)

- The Commercial Appraiser will be responsible for conducting field visits, entering property data, and representing the County at any subsequent appeal hearing.
- Requested Budget \$109,415





- Provide commercial property valuation efforts
- Maintain digest reliability and mitigate risk



#### Personal Property Appraiser I-IV (1)

- The Personal Property Appraiser will be responsible for supporting essential functions which include auditing returns, validating data, and managing delinquency actions.
- Requested Budget \$102,036





- Provide personal property valuation efforts
- Increase delinquency resolutions and improve contractor accountability



#### Residential Appraiser Supervisor (1)

- The Residential Appraiser Supervisor will be responsible for supporting the oversight and management of residential field operations in response to planned growth in appraisal staffing and parcel volume.
- Requested Budget \$124,251
