Gwinnett County publishes for public comment Proposed FFY 2020-2024 Consolidated Plan, Analysis of Impediments to Fair Housing Choice, and FFY 2020 Annual Action Plan, which will be considered for approval by the Gwinnett County Board of Commissioners on **November 5, 2019**.

The Gwinnett County Community Development Program is required to submit to the U.S. Department of Housing and Urban Development (HUD) a multi-year Consolidated Plan describing community needs and funding priorities. This funding document is submitted as a prerequisite to receiving funds for the following programs: Community Development Block Grant (CDBG), Home Investment Partnerships (HOME) Program, and the Emergency Solutions Grant (ESG).

All activities approved by the Gwinnett County Board of Commissioners for funding from the Proposed FFY 2020 Annual Action Plan will receive grant awards upon Gwinnett County’s receipt of the FFY 2020 CDBG, ESG, and HOME grant agreements from HUD.
