PUBLIC COMMENT PERIOD: April 14, 2021 – April 24, 2021

Gwinnett County publishes for public comment a proposed substantial amendment to its [FFY Annual Action Plan 2020](#). The proposed amendment involves a supplemental allocation of Community Development Block Grant (CDBG-CV) and Emergency Solutions Grant (ESG-CV) funds to prevent, prepare for, and respond to coronavirus. The purpose of the public hearing is to receive citizen comments on the substantial amendment.

All activities proposed for funding in the substantial amendment to the FFY 2020 Annual Action Plan will receive grant awards upon the close of the minimum five-day comment period. The public comment period began on April 14, 2021 with the posting on the Gwinnett County website and distribution by e-mail to program stakeholders to inform the public of the proposed Substantial Amendment and inviting comments through April 24, 2020.
