On January 23, 2010, the Gwinnett County Fire Marshal began the *Apartment Inspection Program*. The purpose of the program is to ensure that residents of multi-unit housing are afforded safe and hazard free environments.

The Gwinnett County Fire Marshal will accomplish the objectives of this program by conducting inspections of the interior and exterior areas of Apartment properties. As a general rule, property owners will be required to correct prohibited conditions of the property.

As the Agent or Designee, your consent for the inspection of the property is requested. Please confirm your permission by signing the consent form that is on the back of this document.

You are encouraged to be present during the inspection. Your representative or an agent may also be present.

A Deputy Fire Marshal and designated associates will conduct the inspection in the shortest possible time, while properly performing their duties.

You will receive a copy of the inspection report with all listed deficiencies once the inspection is completed.
