ABOUT GWINNETT

Gwinnett County covers 437 square miles in northeastern Georgia and is located 30 miles northeast of downtown Atlanta. Interstate 85 is the county's main artery and connects to Highway 316, I-285 (the Perimeter), and I-985. Fulton, Forsyth, Barrow, Walton, Hall, Rockdale, and DeKalb counties border Gwinnett.

Gwinnett is one of Georgia's most populous counties with nearly 900,000 residents. We consistently have a relatively low unemployment rate, thanks in part to a public-private economic development effort called Partnership Gwinnett bringing jobs and investments to the area. Our dynamic community also combines the best of big city living with the comforts of the suburbs—arts and culture, professional sports, a variety of housing options, good schools, and nationally recognized parks and libraries.

Gwinnett County Government operates a budget in excess of \$1.5 billion and maintains the distinction of being one of the few counties in the United States to hold a triple-AAA bond rating from all three of the major rating agencies.
