## Reduce your tax bill: apply for homestead exemptions



The best way to reduce your property tax bill is to apply for homestead exemptions. The application deadline is April 1. For all exemptions, you must own and occupy the property as your primary residence as of January 1 of the year for which application is being made. Applications for 2015 exemptions will not be processed after April 1.

You may apply online or contact the Tax Commissioner's Property Tax Department for an application. If you mail the completed application,

please use certified mail; the signed certified signature card along with a postmark on or before the deadline will serve as proof of timely application. Once granted, the homestead exemption is automatically renewed each year.
