Gwinnett 2040 Unified Plan public hearing set for December 19

Gwinnett County is working on an all-encompassing plan to help guide our community's future through 2040, and we need your input.

On **December 19**, the Board of Commissioners is conducting a public hearing on the latest update to the County's comprehensive plan, which Gwinnett calls a Unified Plan, or Gwinnett UP. This will be the public's first opportunity to hear about the content of the Unified Plan, find out times and locations of future meetings, learn about additional ways to provide input, and voice any concerns or issues regarding the plan.



The Unified Plan essentially provides a roadmap for how the County will grow and develop over the next 20 years. In addition to land use, the plan will address the County's needs, opportunities, goals

and vision; community work program; transportation, housing and economic development; natural and cultural resources; and community facilities and capital improvements.

The public hearing is scheduled for 7:00pm at the Gwinnett Justice and Administration Center in Lawrenceville. For more information, contact Interim Planning Director Nancy Lovingood at Nancy.Lovingood@gwinnettcountry.com.

There's still time to comment on the County's proposed 2018 budget

Gwinnett Commission Chairman Charlotte Nash presented a proposed \$1.67 billion budget for fiscal year 2018 to the Board of Commissioners during a briefing on November 28.

The proposed 2018 budget, which focuses on safety and quality of life issues, consists of a \$1.28 billion operating budget and \$390 million for capital improvements, including SPLOST-funded projects.

A team of seven citizen volunteers served on Nash's budget review committee, hearing presentations from elected officials and department directors in late August. The group studied departmental business plans, budget needs, and revenue projections to make recommendations for the 2018 budget.



Commissioners held a public hearing on the proposed budget on Monday, December 4. Written comments are still welcome through an online comment form through **December 31**. The Board expects to adopt the 2018 budget on **January 2**.

Take a survey and help shape development in the Sugarloaf CID

The Sugarloaf Community Improvement District, a self-taxing district, and Gwinnett County have partnered on a study to guide future growth in the Sugarloaf area and your input is needed.

The Atlanta Regional Commission's Livable Centers Initiative is a grant program that encourages local jurisdictions to re-envision their communities as vibrant, walkable places that offer more mobility options, encourage healthy lifestyles, and provide better access to jobs and services. The LCI studies try to spark economic development and quality of life choices.

Once the LCI study is approved by the ARC and Gwinnett County, various projects such as sidewalks, intersection improvements, and streetscaping will be eligible for federal transportation funds routed through the ARC. The study will also guide important planning and zoning decisions within the CID and help prioritize and expedite construction of improvements within the CID.

Gwinnett County Bicentennial Moment - A Step Back in Time



Gwinnett County was created on December 15, 1818, and named for Button Gwinnett, one of the three Georgia signers of the Declaration of Independence.

Formed from land ceded to the state of Georgia by the Cherokee and Creek Indians and a portion of Jackson County, Gwinnett was the 50th county to be organized in the state.

The first courthouse was located at the home of Elisha Winn, near what is now Dacula. Winn was also chosen to select the site for the first county seat and new courthouse. He paid \$200 for a 250-acre lot in the center of the county. Early courthouse business was held in a log cabin until a more permanent structure was built in 1824.
