Probate Court now offers fingerprinting for weapons carry license applicants

Gwinnett County Probate Court now offers fingerprinting for weapons carry license applicants from 8:00am to 4:00pm, Monday through Friday at the Gwinnett Justice and Administration Center. Previously applicants had to visit another office in a different building to be fingerprinted.

Because the weapons carry license application is a three-step process, applications must be received each day no later than 4:00pm. The fee for first-time applicants is \$72.50; there is no additional cost for fingerprinting. The fee for renewal applicants is \$30; renewal applicants are not required to get fingerprinted. Probate Court accepts cash, personal check, money order, and credit card (separate fee for credit card transactions apply).

General Primary election runoff: July 26

A runoff election will take place to select a Republican candidate for State House District 81 on **Tuesday, July 26** from **7:00am to 7:00pm**. This election will only be held for voters who voted a Republican or Nonpartisan ballot in the May 24 General Primary election and are registered to vote at Precinct 38 - Stripling Elementary School, 6155 Atlantic Boulevard in Norcross. No additional runoff elections will be held in Gwinnett County. In addition, if your voting precinct is Stripling Elementary School and you did not vote in the May 24 General Primary, you may vote in this runoff election. There is no runoff for the Democratic ballot.
