Sewer/Septic line connection by a plumber contractor license holder does not require inspection by the Department of Planning and Development for detached one- and two-family dwellings and townhouses separated by a 2-hour fire-resistance-rated wall assembly.

Plumber, Septic, and Utility Contractor License Holders:

- Shall ensure installation of the sewer or septic line connection in accordance with the Georgia State Minimum Standard Plumbing Code and all other applicable ordinances and law.
- Shall ensure connection to the sanitary sewer with an approved 4" x 6" "Fernco" type sealing device for structures served by public sewer.
- Shall indemnify Gwinnett County and its inspectors from any liability for damages and loss of property for any sewer or septic line connection that is not installed in accordance with the applicable codes, ordinances, and law.
