

GWINNETT COUNTY, GEORGIA

CITATION FOR NON-CRIMINAL TRAFFIC SIGNAL VIOLATION

The vehicle described and pictured on the reverse of this citation violated Ordinance No. 110-85 by failing to stop for the circular red or red arrow traffic signal at the place, date and time specified. You are liable for this traffic light violation as the registered owner of this vehicle and must take action before the payment deadline listed on the citation. **The civil monetary penalty for this violation is \$70.00.**

You must either pay the civil monetary penalty or contest liability as outlined below before the payment deadline, which appears on the reverse side of this citation. You may pay by mail (cashier's check or money order only) or in person (cash, money order, cashier's check, Visa, MasterCard or Discover) at the Recorder's Court. PERSONAL CHECKS ARE NOT ACCEPTED.

By paying the civil monetary penalty and not personally appearing before the Court, you are waiving your right to contest liability for this citation.

This traffic light violation is deemed non-criminal and is not considered a moving violation for the purposes of points assessed under **O.C.G.A. § 40-5-7**. The imposition of a civil monetary penalty for this violation shall not be deemed a criminal conviction and shall not be made a part of the operating record of the person upon whom such liability is imposed, nor shall it be used for insurance purposes in the provision of motor vehicle insurance coverage.

Liability for violations of this ordinance shall be determined based upon preponderance of the evidence. Prima-facie evidence that the vehicle described in the citation was operated in violation of Ordinance No. 110-85, together with proof that the defendant was at the time of such violation the registered owner of the vehicle, shall permit the court in its discretion to infer that such owner of the vehicle was the driver of the vehicle at the time of the alleged violation.

To rebut this inference and **contest liability** you may:

- (1) Testify under oath that you were not the operator of the vehicle at the time of the alleged violation;
- (2) Present to the court prior to the payment deadline a certified copy of a police report showing that the vehicle had been reported to the police as stolen, prior to the time of the alleged violation;
- (3) Submit to the court prior to the return date established on the citation, a sworn notarized statement identifying the name and address of the operator of the vehicle at the time of the alleged violation;
- (4) Present evidence to the Recorder's Court prior to the due date that you were not the registered owner of the vehicle at the time and date that the alleged violation occurred; or
- (5) If a commercially licensed vehicle: Within ten (10) days of receipt of this notice, the owner shall provide written notice to the Recorder's Court of the name and address of the driver of the vehicle on the date and time of the violation. Failure of the owner to provide such information within ten (10) days shall cause the owner to be held responsible for penalties imposed.
