Commuter Route 101, 102, 103, and 103A Timepoint Changes – Effective August 31, 2020 (Corrected)

To provide consistency in the myStop app and across all data with our regional partners, Gwinnett County Transit (GCT) will be making changes to the commuter route timepoints beginning on **Monday, August 31, 2020**. The changes will be as follows:

AM Commute (Outbound) – Commuter Routes 101, 102, 103

- Timepoint Civic Center MARTA Station (Stop ID: 20) will change names to W. Peachtree St @ Civic Center Station (SB).
- Timepoint MLK Jr. Dr. @ Peachtree Street (Stop ID: 22) will no longer be a timepoint in the mornings. Instead, the new timepoint will be MLK Jr. Federal Center Annex (Stop ID: 25), and will be called Forsyth Street @ MLK Jr. Dr. (SB).
- Timepoint Mitchell Street @ Washington Street (Stop ID: 23) will no longer be a serviced stop. The new timepoint (last stop) will be named Mitchell Street @ Central Avenue (Stop ID: 520).

PM Commute (Inbound) – Commuter Routes 101, 102, 103

- Timepoint MLK Jr. Federal Center Annex (Stop ID: 25) will have a name change. It will be referred to as Forsyth Street @ MLK Jr. Dr. (SB).
- Timepoint Civic Center MARTA Station (Stop ID: 20) will change names to W. Peachtree St @ Civic Center Station (SB).
- Timepoint Mitchell Street @ Washington Street (Stop ID: 23) will no longer be a serviced stop.

AM Commute (Inbound) and PM Commute (Outbound) – Commuter Route 103A

- Timepoint MLK Jr. Federal Center Annex (Stop ID: 25) will have a name change. It will be called Forsyth Street @ MLK Jr. Dr. (SB).
- For this route ONLY, stop name Civic Center MARTA Station (Stop ID: 20) will be an intermediate stop named W. Peachtree St @ Civic Center Station (NB) (Stop ID: 1066).
- Intermediate stop W. Peachtree St. and 10th St (Stop ID: 843) will be published as W. Peachtree St. and Peachtree Place.
- Published Timepoint Shackleford Rd @ Pine Road will be replaced with Timepoint Shackleford Rd @ Kaiser Permanente (Stop ID: 28).
- Published Timepoint Shackleford Rd @ Pine Road (Stop ID: 741) will become an intermediate stop.
- Intermediate stop Breckinridge Blvd and Brookview Dr. (Stop ID: 156) is no longer a serviced stop.
