RATES EFFECTIVE August 1, 2019

SITE DEVELOPMENT PERMIT

Fees are due prior to site plan approval.

- T.V. INSPECTION FEE:** \$45.00 plus \$0.30 per linear foot of 8" or larger sewer pipe and/or 18" or larger storm pipe.
NOTE: Additional fees for TV inspection will be required if approved in more than one phase or unit. This fee will be collected at the time of re-approval. If a re-inspection fee is necessary, the additional inspection fees will be collected after TV Inspection is completed.
- NEW STUB OFF EXISTING SEWER LINE :** \$550.00

BUILDING PERMIT

Meter fees are due prior to building permit authorization or vault utility construction permit issuance. Fees are determined by the size water meter required for the project.
