ONCE COMPLETE VARIANCE PACKAGE WITH ALL SUPPORTING DOCUMENTATION HAS BEEN RECEIVED, ALLOW TEN (10) BUSINESS DAYS FOR RESPONSE. **IF THE VARIANCE IS APPROVED, ANY CHANGES IN THE DESIGN OR CONSTRUCTION INCLUDING BUT NOT LIMITED TO SIZE, DEPTH, LOCATION, FLOWS, ENCROACHMENTS, AND/OR ANY OTHER CONDITION AFFECTING THE GWINNETT COUNTY SYSTEM AND FACILITIES, WILL VOID AND NULLIFY THE VARIANCE. SUCH CHANGES MUST BE SUBMITTED TO GWINNETT COUNTY AS A NEW AND SEPARATE VARIANCE REQUEST FOR REVIEW AND PROCESSING. PRIOR VARIANCE REQUEST APPROVAL DOES NOT GUARANTEE FUTURE APPROVALS.**
