1. When asked at the April 17th meeting about a timeline we were told that there is no timeline, why is there a delay? Where can the updates and timeline be viewed?

The timeline for the restoration process includes current meetings held with Lord Aeck Sargent (LAS) to plan and coordinate the community outreach and engagement phase which is planned to take place this Fall. This will include at least two events which will be planned at different times of the day/week to allow for greater participation. Additionally, we've discussed having an online survey be available for input and feedback.

At the conclusion of this initial process, the information and input received will be complied to provide design direction for the County and LAS to develop a request for proposal for a Construction Manager at Risk procurement of a historic restoration construction manager (CMAR).

- 2. What specific actions have been taken on the project since 2018?
 - March 2019 Additional 1.8-acre land parcel purchased for the Promised Land site
 - October 2019-through 2022 Research and development for interpretation plan began and continues
 - January 2020-April 2020 Demolition of non-historic structures completed by Gwinnett County and an external vendor
 - August 2021-October 2022 Partnership with Atlanta History Center for oral histories initiated and continues
 - January 2022 SPLOST funding becomes available for house restoration planning and development within 2017 SPLOST Funding
 - July 2022- Contract development with LAS began
 - December 2022- BOC approved contract with LAS
 - February 2023- Contract with LAS executed
- 3. Where can I see maintenance records for the Big House?

Inspection and other maintenance records for the house and site can be provided to HRPB Board Members. Staff will provide these documents.

4. Is Ruth Abram still involved in the project? will any of her work be used? Or is that part of the project being handled by Lord Aeck Sargent?

Ruth Abram is not involved in the restoration project. Lord Aeck Sargent has a specialized team of historic preservation architects which focus on analyzing and restoration of historic structures.

5. Will the HRPB be able to review the RFPs/RFQs before a qualified contractor is selected by Lord Aeck Sargent?

LAS will not be selecting the CMAR. The CMAR must be selected through the procurement process managed by the County Purchasing Division, which doesn't involve outside entities. The RFP process will be limited to vendors that have extensive experience with similar types and scope of building restorations.

6. The contract requires Lord Aeck Sargent to attend one community outreach meeting. Will the CM at Risk be required to attend more community outreach meetings, or will this be the responsibility of DOCS staff?

The extent of the community outreach has yet to be determined but LAS will be involved to the extent necessary. There would be no reason for the CMAR to attend any community outreach.

7. What other projects have been started and/or accomplished since 2016?

Numerous projects of all different sizes and scopes which were budgeted for have been completed since 2016. There was no specific funding allocated to this project until 2022.

 Please provide a breakdown of the approximately \$630,000 of 2017 SPLOST money that has been spent on the Promised Land Project as stated by Dr. Patterson (refer to Gwinnett Historical Restoration & Preservation Board Monday, September 19, 2022 – 6:00pm).

As provided via email on July 15, 2022, below is a summary of expenses to date for The Promised Land Project:

- Land Acquisition (incl legal fees and taxes assoc. with purchase) \$464,601.43
- Appraisals \$15,650
- Consultants (includes historical structure report & boundary surveys) \$74,456.54
- Additional Consultant R. Abram \$61,276
- Additional Consultant E. Olson (Genealogy) \$9,800
- Additional Consultant B. Stock (Genealogy) \$4,830

Total of expenses: \$630,613.97

9. During the July 18th, 2022, HRPB meeting we were told that "stakeholder involvement occurs during the phase of the project after the RFP is awarded".

This references an RFP for design services. Because this is a specialized project the design services can be procured through an exemption in the Purchasing Policy guidelines, which is how we contracted with LAS. Stakeholder involvement will be through the public engagement process where any interested party may attend and all stakeholder voices will be included.

10. I know many members of the community would like to be involved with the project – How can community members get involved?

The community members will have the opportunity to engage in at least two open houses where input and involvement will be encouraged. These events will be advertised through social media, County web site, signs and banners and any other means to help maximize turn out.

Historian Porter suggested including advertisements in the Gwinnett County Water Bill Newsletter.

11. Are community outreach meetings scheduled? What are the dates of these meetings?

They have not been scheduled yet. Historically the summertime is not a good time for gathering input and getting community involvement. The plan is to continue planning this summer and have the events this Fall.


