  - 89 Animals placed



# **Shelter Operations Updates**

- 125 Unassisted deaths
  - 61 Kittens, 19 cats, 25 dogs, and 20 wildlife
- 44 Rabies vector euthanasia of wildlife animals
- 19 Felines sent for rabies testing
  - 5 from Gwinnett AWE and 14 from animal hospitals
- 49 Canines sent for rabies testing
  - 16 Gwinnett AWE and 33 from animal hospitals
  - Total impounds YTD- 5370:578 cats,1427 kittens,3056 dogs, 309 others- wildlife, reptiles, goats, fowl, birds, guinea pigs.
