

Construction Update

Georgia Animal Related Legislative Passed Bills

- HB 331: Prohibits the sale/barter of dogs, cats, and rabbits in unregulated public locations (e.g., parking lots, roadsides).
 Exempts licensed shelters/rescues and allows certain prearranged transfers.
- HB 177: Extends protective orders in domestic violence cases to include household pets.






- 1,056 Hours (Dogs)
