Authorization for the delegation of authority to the County Administrator to approve guaranteed maximum price (GMP) authorizations and associated change orders. Contract to follow award. Subject to approval as to form by the Law Department. This contract is funded 3.8% by the American Rescue Plan Act.
- XIII. Approval/authorization for the Chairwoman to execute an Intergovernmental Agreement (IGA) between Gwinnett County, the Gwinnett County Water and Sewerage Authority, and DeKalb County to outline the responsibilities of the parties as it pertains to sewer services. Subject to approval as to form by the Law Department.
- XIV. Approval/authorization for the Chairwoman to execute a Development Participation Agreement (DPA) between Gwinnett County, Gwinnett County Water and Sewerage Authority, and Lake Blue Ridge Land Company, LLC, to outline the responsibilities of the parties as it pertains to the installation of a sewerage pump station for a proposed development located at the intersection of North Bogan Road and Hamilton Mill Road in the City of Buford. Lake Blue Ridge Land Company, LLC will pay Gwinnett County two hundred thousand dollars (\$200,000.00) for future operations and maintenance charge of the pump station.
