i. Collection of Federal Stormwater Fees Update (Katherine Gurd)

DWR is actively pursuing and collecting delinquent fees. Army Corps of Engineers: On-going discussions; meeting scheduled for July. Many other delinquent accounts have a payment plan arranged.

Lien question response from April 16, 2021, meeting: Liens are prohibited by the stormwater utility ordinance.

ii. Stormwater Pipe Trends (Katherine Gurd)

DWR owned/maintained pipe mostly under roadways and in ROW. Most failing pipes are CMP; no longer approved to be installed in Gwinnett, most pipe failures appear to be the result of pipes reaching End of Useful Life (EUL).

SWA Comments: After lining, how much more EUL obtained from pipe?

We are told lining adds around 75 years of useful life.

iii. Roads over Dams Update (Katherine Gurd)

Gwinnett County Dam Program: 25 Dams are maintained by DWR; have identified additional dams under County roads.

Provided updated information to the SWA clarifying areas of responsibility to maintain dams by DWR, DOT, cities, and private dam owners.

SWA Comments: What determines exemption?

Georgia safe dams determines which dams are regulated by size
