



management, education, and prevention services for Gwinnett, Newton and Rockale (GNR) Counties. Epidemiology staff perform routine surveillance for over 70 notifiable diseases and provide key disease prevention and control activities protecting the health of the community. Key programmatic areas include: Notifiable Disease Epidemiology, Tuberculosis (TB), and Sexually Transmitted Infections (STI).

In addition to disease surveillance and control functions for notifiable diseases, GNR Epidemiology staff: investigate reports of non-reportable diseases such as Norovirus, head lice, and scabies; complete data requests from community partners and the general population; participate in community health assessment and improvement planning; provide infection control guidance and trainings; and collaborate with community partners including schools, hospitals, daycares, skilled nursing facilities, etc. to control the spread of infectious diseases. GNR Epidemiology also assists and provides field investigations as requested by GA DPH and CDC.


Investigations of notifiable disease are prioritized based on the following: GA Department of Public Health, CDC, and GNR Health Director guidance; the population affected (high-risk or susceptible); ability to implement effective control measures (including timeliness of reporting); and GNR resources/staffing. For Sexually transmitted inflections (STI), investigation and prevention services are prioritized for HIV and Syphilis. Due to significant Gonorhea and Chlamydia morbidity, investigation and follow up are limited to infections in teens, patients tested in GNR clinical facilities, and prepant women.



Zika Virus: A Global Health Emergency





• Primarily Transmitted Through the Bite of an Infected *Aedes* Mosquito.

- Can Also Be Transmitted Through Blood and Bodily Fluids.
- Spread Rapidly Through the Americas Starting with a Large Outbreak in Brazil in Late 2015.
- Linked to Significant Birth Defects, Including Microcephaly, in Children Born to Mothers Infected During Pregnancy.
- As of November 23, 2016, 4,444 Cases Have Been Reported in the United States.
 - 183 Locally Acquired in Florida.
 - 102 Travel Associated Cases in Georgia.
- Gwinnett Public Health Continues to Investigate **ALL** Reported Cases and Provide Education and Testing as Appropriate.



Gwinnett County Zika Virus Response



- Zika Virus Emerged as a Global Public Health Threat in January 2016.
 - Incident Command Structure was Quickly Established to Respond and Protect the Citizens of Gwinnett County.
- With the Assistance of Chairman Nash, Public Health Coordinated Response Planning Efforts with Gwinnett Officials from Fire, Police, Code Enforcement, Animal Control, Parks & Recreation, Planning & Development, Water Resources, and Senior Services, as well as Local Partners including UGA Extension Gwinnett.
- Efforts Focused on Coordinated and Consistent Prevention Messaging.
- Tip N'Toss (Reduction of Mosquito Breeding Grounds).
- Utilization of EPA-approved Insect Repellent.
- Avoiding Travel to Affected Areas During Pregnancy.




2017 Proposed Budget \$1.56 Billion




2017 Operating Budget: \$1.18 Billion











LIGHT ETP

Listening, Inspiring, Guiding Healthy Transitions (LIGHT) Early Treatment Programs (ETP) is aimed at improving the lives of youth and young adults ages 16-25 with mental health conditions or co-occurring mental and substance use disorders so they will become healthy and independent adults in their communities. In FY16 this program provided 460 sessions.

Assertive Community Treatment

ACT is a client-centered, recovery oriented and highly intensive community-based service for individuals with severe and persistent mental illness.

View Point Health offers two ACT teams available seven days a week, 24 hours a day by direct phone link and is regularly accessible to clients who work or who are involved in other scheduled vocational or rehabilitative services during the daytime hours.



Gwinnett Team FY16

- Served 117 clients total
- Less than 5 Inpatient admissions per month
- Average of 11 clients employed per month
- 0.375 days incarcerated per client
- 96% of clients were prevented from more restrictive service
- 98% of clients housed

Intensive Case Management

The philosophy of ICM services is to assist individuals in reaching their optimum level of wellness and functional capacity through advocacy, education, communication, identification of service resources and service facilitation resulting in less incarcerations, hospitalizations, and episodes of homelessness.

- ✓ 92% prevented from more restrictive service

Temporary Observation Unit


The 23-hour observation program provides a physically secure and medically safe environment for up to 23:59 hours during which an adult in crisis is rapidly assessed, stabilized and referred to the next appropriate level of care.

This program is co-located in the Adult Crisis Stabilization Unit in Lawrenceville.



Adult Crisis Stabilization Unit Orders to Apprehend (OTA)

The Crisis Stabilization Unit has evaluated 65 individuals on an OTA since Sept 2015.



- Based on two affidavits from concerned parties, the probate judge can order for the county sheriff to apprehend the mentally ill person and transport him/her to a psychiatric facility for evaluation.
- The evaluation may result in involuntary psychiatric hospitalization. The court order to apprehend the person is valid for 7 days.

Re-Entry Intervention Programs

Gwinnett Re-Entry Intervention Program (GRIP) and Rockdale Re-Entry Intervention and Prevention Program (RRIPP) are collaborations between the County Sheriff's Department and United Way. In partnership with View Point Health and other community service agencies the Re-Entry Programs strive to reduce the number of incarcerated individuals returning to jails or prisons.

- Housing Supports and Case
 Management
- Connection to Mental Health and Primary Care Services
- Supported Employment Services
- Screening and Application for Benefits (SSI/SSDI, Food stamps)
- Financial Literacy Courses




