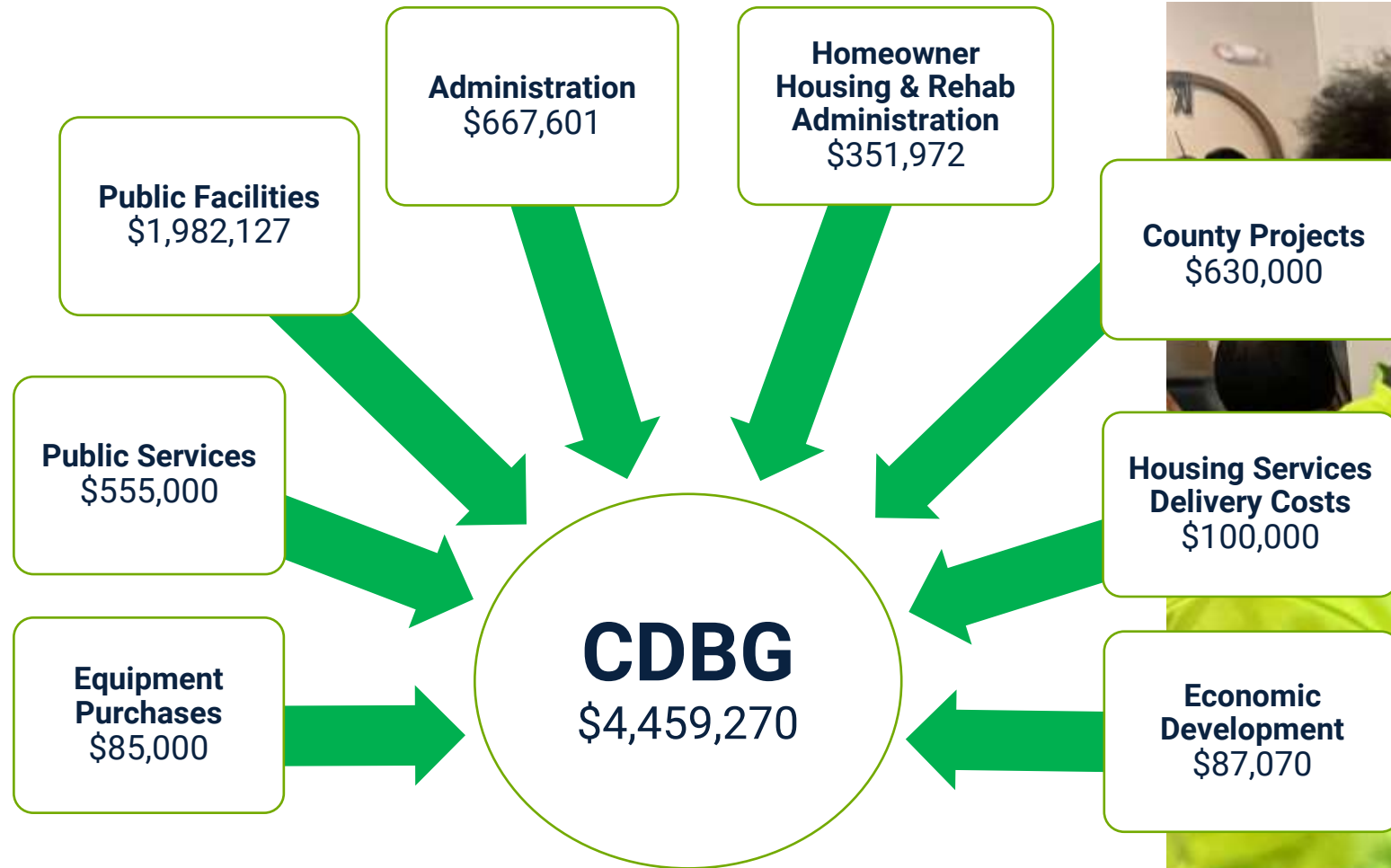
# FFY 2022 Requests vs. Funding Levels

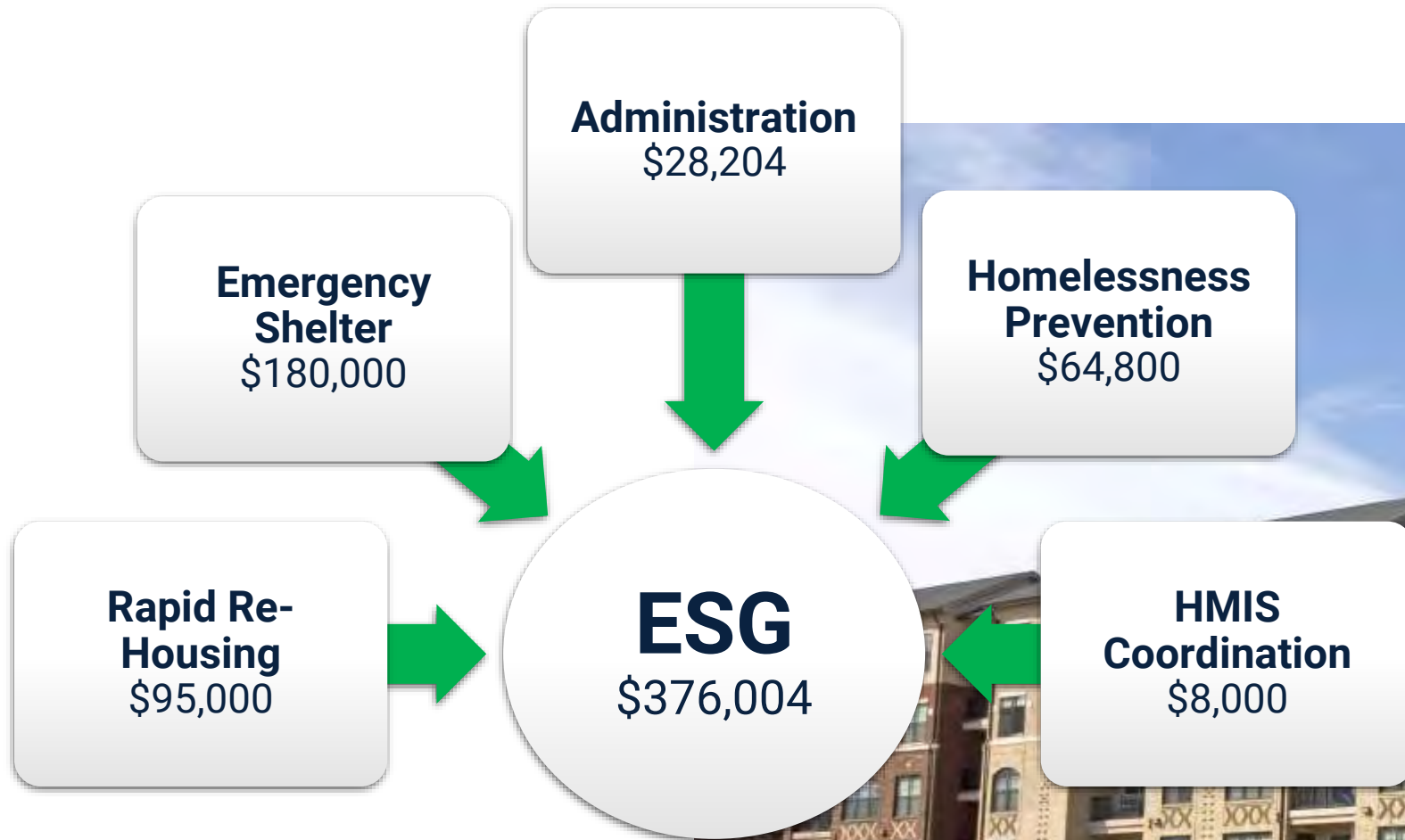
