2025-0786 Approval to appoint Dena Bosten to the Audit Committee representing Internal Auditor or Certified Public Accountant. Term expires December 31, 2028. Incumbent Teresa Reese. Board of Commissioners Appointment

2025-0787 Approval to appoint Greg Johnson to the Audit Committee representing Local Government Practitioner from Outside Gwinnett County. Term expires December 31, 2028. Incumbent Tracy Arner. Board of Commissioners Appointment
