October 17 – October 19, 2025

WHEREAS, Established in 2012, Volunteer Gwinnett is a comprehensive, countywide volunteer program that promotes community service and volunteerism in Gwinnett County; and

WHEREAS, Each fall, Volunteer Gwinnett coordinates Gwinnett Great Days of Service, the largest community volunteer initiative in the county, organizing thousands of dedicated residents, corporations, schools, civic organizations, and nonprofits for a focused weekend of community building and positive impact; and
