## GWINNETT COUNTY BOARD OF ASSESSORS January 2, 2013

The regular meeting of the Gwinnett County Board of Assessors took place Wednesday, January 2, 2013 at 9:00am. Those in attendance were Norman Nash, Chairman; Robert Chaapel, Vice-Chairman; Norma Holliman, Assessor; Sue Seibenhener, Assessor; Bob Griggs, Assessor; Mike Ludwiczak, Senior County Attorney; Steve Pruitt, Executive Secretary and Ginger Roderick, Recording Secretary.

Chairman Nash called the meeting to order and asked for the election of the 2013 Board of Assessors Officers under Roberts Rules of Order. Ms. Seibenhener made a motion to retain Norman Nash as Chairman. Ms. Holliman seconded, and so carried unanimously.

Ms. Holliman made a motion to retain Robert Chaapel as Vice-Chairman. Ms. Seibenhener seconded, and so carried unanimously.

Ms. Seibenhener made a motion to appoint Steve Pruitt as Executive Secretary. Vice-Chairman Chaapel seconded, and so carried unanimously.

Ms. Seibenhener made a motion to appoint Ginger Roderick as Recording Secretary. Vice-Chairman Chaapel seconded, and so carried unanimously.

Ms. Seibenhener made a motion to appoint Steve Pruitt as Chief Appraiser. Ms. Holliman seconded, and so carried unanimously.

Ms. Holliman made motion to appoint Stewart Oliver as Deputy Chief Appraiser. Ms. Seibenhener seconded, and so carried unanimously.

The Board reviewed the minutes of December 19, 2012. Chairman Nash asked if there were any corrections or additions to be made. Ms. Seibenhener made a motion to approve minutes. Ms. Holliman seconded, and so carried unanimously.
