Unofficial Minutes GWINNETT COUNTY BOARD OF ASSESSORS April 18, 2018

The regular meeting of the Gwinnett County Board of Assessors took place Wednesday, April 18, 2018 at 9:00am. Those in attendance were Norman Nash, Chairman; Robert Chaapel, Vice-Chairman; Johnny Blan, Assessor; Norman B. Ellis, Assessor; Sue Seibenhener, Assessor; Stuart Morelli, County Attorney; Stewart Oliver, Executive Secretary and Ginger Roderick, Recording Secretary.

Chairman Nash called the meeting to order and asked for approval of the agenda. Ms. Seibenhener made motion to approve the agenda. Vice-Chairman Chaapel seconded, and so carried unanimously.

The Board reviewed the minutes of April 4, 2018 regular meeting. Chairman Nash asked if there were any corrections or additions to be made. Ms. Seibenhener made motion to approve the minutes. Mr. Blan seconded, and so carried unanimously.

Under Old Business was Legal Opinions. There was a discussion regarding CUVA releases. There was a discussion regarding identifying multi-family units in a multi-use parcels.
