Unofficial Minutes GWINNETT COUNTY BOARD OF ASSESSORS November 7, 2018

The regular meeting of the Gwinnett County Board of Assessors took place Wednesday, November 7, 2018 at 9:00am. Those in attendance were Johnny Blan, Vice-Chairman; Norman Ellis, Assessor; Burt Manning, Assessor; Sue Seibenhener; Assessor, Forrest Fields, County Attorney; Stewart Oliver, Executive Secretary and Ginger Roderick, Recording Secretary.

Vice-Chairman Blan called the meeting to order and asked for approval of the agenda. Mr. Manning made motion to approve the agenda. Mr. Ellis seconded, and so carried unanimously.

The Board reviewed the minutes of October 17, 2018 regular meeting. Vice-Chairman Blan asked if there were any corrections or additions to be made. Mr. Manning made motion to approve the minutes. Mr. Ellis seconded, and so carried unanimously.

Under Old Business was Legal Opinions. None pending. In the interim, Forrest Fields will be the attorney attending for the law department. Approval is needed for letter to be sent to CUVA parcel, letter of breach. Mr. Manning made motion to approve letter to be sent. Mr. Ellis seconded, and so carried unanimously.

Next under Old Business was Value Update. Mr. Oliver informed the Board that we are awaiting a consent order so we can close out the 1 commercial appeal that remains open for 2017. For 2018 – Mr. Oliver shared with the Board the 2018 Property Tax Appeals Report for an overview of appeals. The overall value in dispute lost to date is 43%. 2019 – We are currently reevaluating commercial land for both improved and vacant parcels and land for exempt properties. For Residential 2019 projects, we are updating all land tables for small and large tracts. This is a uniformity study and will likely result in a mixture of both increasing and decreasing property values. There is 3,500 new parcels projected for 2019.
