## GWINNETT COUNTY BOARD OF ASSESSORS January 6, 2021

The regular meeting of the Gwinnett County Board of Assessors took place Wednesday, January 6, 2021 at 9:00am. Those in attendance were Norman Nash, Chairman (via remote); Johnny Blan, Vice-Chairman (via remote); Sue Seibenhener, Assessor (via remote); Norman Ellis, Assessor (via remote); Burt Manning, Assessor (via remote); Stewart Oliver, Executive Secretary and Ginger Roderick, Recording Secretary.

Chairman Nash called the meeting to order and asked for election of the 2021 Board of Assessors Officers under Roberts Rules of Order. Mr. Manning made a motion to retain Norman Nash as Chairman. Ms. Seibenhener seconded, and so carried unanimously.

Mr. Manning made motion to retain Johnny Blan as Vice-Chairman. Ms. Seibenhener seconded, and so carried unanimously.

Mr. Manning made motion to appoint Stewart Oliver as Executive Secretary, Ms. Seibenhener seconded, and so carried unanimously.

Mr. Manning made motion to appoint Ginger Roderick as Recording Secretary. Ms. Seibenhener seconded, and so carried unanimously.

Mr. Manning made a motion to appoint Stewart Oliver as Chief Appraiser. Ms. Seibenhener seconded, and so carried unanimously.

Mr. Manning made a motion to appoint Alex Alcock as Deputy Chief Appraiser. Ms. Seibenhener seconded, and so carried unanimously.

For 2021 Value Udpate Mr. Alcock shared some of the market analysis of sales that occurred through November 2020.

Hearings – Virtual hearings are being held and are going very well. Clerk of Courts are still operating with just 2 Boards of Equalization. Policy – Discussion took place about Policy – In Person Hearings. Mr. Ellis made motion to approve for policy. Ms. Seibenhener seconded, and so carried unanimously.

Chairman Nash asked if there was any other business to be discussed. There being none Ms. Seibenhener made motion to adjourn. Mr. Ellis seconded, and so carried unanimously.
