GWINNETT COUNTY BOARD OF ASSESSORS October 6, 2021

The regularly scheduled meeting of the Gwinnett County Board of Assessors took place Wednesday, October 6, 2021, at 9:00 am. Those in attendance were Johnny Blan, Chairman; Burt Manning, Vice-Chairman; Norman Ellis, Assessor; Sharyl White, Assessor; Mark Cooper, Assessor; Alex Alcock, Deputy Chief Appraiser and Ginger Roderick, Recording Secretary.

Chairman Blan called the meeting to order and asked for approval of the agenda. Vice-Chairman Manning made a motion to approve the agenda. Ms. White seconded and so carried unanimously. Mr. Nathan Woods was also introduced as our new County Attorney that will be representing the Assessor's Office.

The Board reviewed the minutes of the September 15, 2021, regular meeting. Chairman Blan asked if there were any corrections or additions to be made. Ms. White made a motion to approve the minutes. Mr. Ellis seconded and so carried unanimously.

Next under Old Business was Value Update. Appeals exist for the current and prior years. There is a single 2018 appeal, three from 2019, 56 from 2020 and 1,919 open appeals for 2021. Overall, the appeals continue to progress.

Under Other Business, Chairman Blan asked if there were any Administrative and Policy Updates. Mr. Alcock announced that there currently are two vacancies for appraiser positions. An offer has been made for one appraiser position waiting for Human Resources to process. We received a resignation from Ava Dupree who has announced her retirement as of 10/21/21, this will leave us with a vacant ASA II position and will post as soon as possible.

Chairman Blan asked if there was any other business to be discussed. There being none, Vice-Chairman Manning made the motion to adjourn. Mr. Ellis seconded and so carried unanimously.
